- 6) Handicapping: All classes except One Design shall submit a current 2008 rating certificate from a cognizant rating authority prior to the entry deadline. If you have previously submitted the applicable 2008 rating certificate to Lakewood Yacht Club, there is no need to resubmit for this race. Lakewood Yacht Club Race Committee will maintain a master rating certificate file for all boats racing in LYC's races for 2008. Multihull ratings must be obtained through TOMA.
