1. **Rules:** The race will be governed by the rules as defined in "The Racing Rules of Sailing 2005-2008."
2. **Courses:** The race area will be in Galveston Bay, East of Seabrook Channel Marker #2 and West of the Houston Ship Channel.
3. **Classes:**

Windward/Leeward Courses: Classes require a minimum of five boats. Potential classes include PHRF Spinnaker, Level 70/ORC Club, J/80 and other One Design classes.

Distance Course: Classes require a minimum of four boats. Potential classes include ORC Club Spinnaker and Non Spinnaker, PHRF Non Spinnaker, Shorthanded Offshore Sailors (SOS), All Women Crew, and Multi-Hull.

5. **Handicapping:** All classes except One Design shall submit a current 2007 rating certificate from a cognizant rating authority **prior to the entry deadline**. Certificates shall be hand delivered or faxed to Lakewood Yacht Club, 281-474-3502. Multihull ratings must be obtained through TOMA. These requirements are an unconditional prerequisite for entry. No "club handicaps" will be assigned by the Race Committee. Please contact the following authorities for a rating certificate:

6. The Race Committee may, in its discretion, accept a late filed rating certificate.
7. **Conditions of Entry:** Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (Bay Access, Inc., Lakewood Yacht Club, Race Committee, Protest Committee, sponsors, or any other organization or official) will not be responsible for damage to any yacht or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
8. **Insurance:** Each participating yacht shall be insured with valid third-party liability insurance with a minimum coverage of \$300,000 per event or the equivalent.
9. **Waivers:** No skipper or crew member shall participate without signing and turning in to the Race Committee the waiver of liability in this NOR before the Skippers' Meeting. Waivers from individual crew members may be faxed to Lakewood Yacht Club, 281-474-3502 (crew signatures must be witnessed).
10. **Entry Fees:** The Entry Fee is \$45. A \$5 discount is available for US SAILING Members. The Entry Fee is payable by credit card, yacht club reciprocal charge, or check. Entry fees will be

refunded if a registrant notifies the Race Committee of the withdrawal prior to the Entry Deadline.

11. **Entry Deadline:** The Entry must be submitted by 1700 hours on Wednesday, May 16, 2007. Late entries may be accepted at the discretion of the Race Committee but will require a \$50 tax-deductible donation to Bay Access, Inc.
12. **Sailing Instructions:** The Sailing Instructions will be available at the Skippers' Meeting.
13. **Notices to Competitors:** Notices to Competitors will be posted on the Official Race Notice Board of Lakewood Yacht Club located near the west end of the swimming pool.
14. **Scoring and Prizes:** Awards shall be presented to no more than 3 places in each class. ORC Club scoring will use performance line circular random scoring. PHRF scoring will use time on distance scoring.
15. **Docking/Launching:** Competitors are welcome to leave their boats in the Inner Harbor of LYC for the duration of the Regatta. Launching cranes and ramps are available at no charge. Reservations must be made in advance by contacting the LYC Harbor Administrator, Joan Cordes, at 281-474-2540.
16. **Advertising:** As a courtesy to our valued race sponsors, no advertising may be displayed on Lakewood Yacht Club premises without prior written permission of the Race Committee.
