 sustained as a result of my participation in this event, regardless of the fact that such damage may, in whole or in part, be due to the negligence of Lakewood Yacht Club, Bay Access, Inc., the Race Committee, the Harvest Moon Regatta Committee, the sponsors of the Harvest Moon Regatta, the Protest Committee, or their respective members, officers, board of directors, staff or representatives.

I hereby WAIVE any rights I may have to sue the Race Organizers (including Lakewood Yacht Club, Bay Access, Inc., the Race Committee, the Harvest Moon Regatta Committee, the sponsors of the Harvest Moon Regatta, the Protest Committee, and/or their respective members, officers, board of directors, staff or representatives) with respect to personal injury or property damage suffered as a result of my participation in this event and hereby RELEASE the Race Organizers from any liability for such injury or damage to the fullest extent permitted by law whether caused in whole or in part by negligence.
