

Notice of Race 2015 BAYS Summer Series Regatta #1 at PYSF May 16-17, 2015

1. Eligibility & Fees

1.1 There will be starts for C420, CFJ, Laser Radial, Opti Championship and Opti Green.

1.2 A minimum of five boats is needed to constitute a fleet.

1.3 Results will be scored as part of the BAYS 2015 Summer Series

1.3 Eligible boats may enter at the following link by Wednesday, May 13. Bring the attached Entry Form to Registration on Saturday morning. Advanced registration is *mandatory*.

1.4 The entry fee for this regatta is \$40 per sailor. Lunch and a light snack after racing will be provided.

2. Rules

2.1 The Regatta will be governed by The 20013-2016 Racing Rules of Sailing, the prescriptions of US Sailing, and as modified by the NOR and Sailing Instructions for this Regatta.

2.2 Competitors are required to carry a bowline of at least fifteen feet attached to a towing point while racing.

3. Schedule of Events*

Saturday, May 16, 2015 0830-0930: Registration & Rigging 1000: Competitors' Meeting 1130: First Race. 4 Races Scheduled After Racing: Light Snack Sunday, May 17, 2015 0930: Competitors' Meeting 1100: First Race. 4 Races Scheduled 1600: No race started after this time 1700: Awards Presentation adjacent to PYSF classroom *Eight Races Scheduled for Outside Course. All times are approximate. *

4. Racing Area - The race course will be located just outside Redwood Creek for Opti Champ, C420 and Laser Radial. The Opti Green and CFJ Fleets will be inside the turning basin adjacent to PYSF.

5. Coaching - Coaching is not permitted during racing. Between races, coaching will be permitted, but coach boats shall not enter the racing area. All coach boats must also act as safety boats. Each boat must carry a VHF radio. Every coach of the C420 Fleet must be US Sailing Level 3 certified.

6. Safety - Each competitor must wear adequate buoyancy, properly secured at all times, on the dock and while on the water. Wet suits, dry suits and inflatable PFDs do not constitute adequate buoyancy.

7. Liability – Participants compete entirely at their own risk. Each competitor and their parent/guardian must sign a waiver before competing.
