# SAILING INSTRUCTIONS FOR INLAND LAKE YACHTING ASSOCIATION (ILYA) E INVITATIONAL REGATTA

JULY 9-12, 2015 MINNETONKA YACHT CLUB DEEPHAVEN, MINNESOTA

Headquarters: Minnetonka Yacht Club, Lighthouse Island ILYA Regatta Representative: Vincent Porter (All times given are Central Daylight Time)



Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (the organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor, or in the case of minors, each competitor's parent or guardian agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

# 1. RULES

The regatta will be governed by the rules as defined in the current *Racing Rules of Sailing* and the scantling rules of the National Class E Scow Association, and NCESA By-laws Articles V, VI and VIII, parts 4, 5 and 7. Crew changes from race to race are allowed during this event.

# 2. ENTRIES

The regatta is open to Class E Scows. Helms-persons shall be Regular, Family, Youth or Life Members of the ILYA. Eligible boats may be entered by completing registration with the Association.

#### 3. NOTICES TO COMPETITORS

Notices to competitors will be posted on the Regatta Notice Board located at Lighthouse Island.

# 4. COMPETITORS' BRIEFING MEETING

The competitors' briefing will be at 8:30 a.m., Friday, July 10, at Lighthouse Island and by VHF radio on the Competitors' channel, VHF 72.

# 5. CHANGES TO SAILING INSTRUCTIONS

Any changes to the sailing instructions (SI) will be posted no later than 90 minutes before the first warning signal on the day it will take effect. Except that any change in the schedule of races will be posted by 6:00 p.m. on the day before it will take effect.

#### 6. SIGNALS MADE ASHORE

- 6.1 Except as noted in SI 6.2, signals made ashore will be displayed by the Signal Boat at the dock at Lighthouse Island.
- Flag "F," displayed from the main flag pole on Lighthouse Island at least one hour prior to the warning signal of the race or races in which it applies, means that all boats are required to sail with NCESA mainsail flotation panels installed. Flotation requirement will remain in affect until Flag "F" is removed which will be done with one sound signal and announced on the competitor channel.
- 6.3 When the Answering Pennant ("AP") is displayed ashore, '1 minute' is replaced with 'not less than 45 minutes in the Race Signals AP'.
- Approximately one hour prior to the scheduled warning signal of the first race of the day, the signal boat will fire a gun, or make another sound signal.

# 7. NUMBER AND SCHEDULE OF RACES

- 7.1 Seven races are scheduled, of which two must be completed to constitute a regatta.
- 7.2 The Warning Signal for the first race, July 10, will be at 10:00 a.m. Except when races are sailed back-to-back, the approximate time of the warning signal for subsequent races will be posted on the Regatta Notice Board and/or announced on the competitor's radio channel.
- 7.3 If two races are completed, no warning signal will be made after 12:00 p.m. on Sunday, July 12.
- 7.4 In any case, no warning signal will be made after 1:00 p.m. on Sunday, July 12.

# 8. CLASS FLAG

The class flag will be a NCESA flag.

## 9. RACING AREA

The racing area will be the navigable waters of Lake Minnetonka.

#### 10. THE COURSE

- 10.1 The courses and their designations are shown as COURSE ILLUSTRATIONS.
- 10.2 No later than the warning signal, the race committee signal boat will display the course designation and approximate compass bearing to the first mark.
- Marks shall be rounded to port, except that when there is a leeward gate, boats shall sail between the gate marks from the direction of the previous mark and round either gate mark. If one of the gate marks is missing, boats shall round the existing leeward mark to port.
- 10.4 Minor adjustments in a mark's location will not be signaled. This changes RRS 33.
- 10.5 For the final mark rounding in courses L4 & L6, boats shall round mark Gp to port, and then proceed to the finish line as indicated in the course illustration.

#### 11. MARKS

- 11.1 Original marks will be yellow inflatables.
- An offset mark (small pink or red ball) may be set adjacent to the windward mark. An offset mark (if set) is a mark of the course, and shall be rounded to port after rounding the windward mark.
- 11.3 New marks used in accordance with RRS 33 will be orange inflatables.
- 11.4 A finish mark, if used at the finish of courses L4 or L6 will be a green inflatable.

# 12. THE START

- 12.1 Races will be started by using RRS 26.
- The starting line will be between a staff displaying an orange flag on a Race Committee boat and the course side of a nearby mark, or between staffs displaying orange flags on two Race Committee boats.
- 12.3 A boat starting later than five minutes after her starting signal will be scored DNS. This changes RRS A4.1.
- 12.4 If the race is abandoned after the starting signal under the Z or Black Flag, all competitors who received a 20% scoring penalty under the RRS 30.2 or were disqualified under the RRS 30.3 in the abandoned race are again eligible to race without penalty. This changes RRS 30.2 and 30.3.

# 13. RECALLS

- 13.1 Boats that are OCS under an individual recall will be notified on VHF 72, and possibly by hail.
- Following the display of Flag "X", every effort will be made as quickly and clearly as possible, to hail by VHF radio a complete list of boats identified on the course side at the start or needing to comply with RRS 30.1. Please note that due to this hail being a courtesy, it is extremely unlikely that redress will be granted because of the order of numbers called, failure to hear a hail, or failure to understand a hail. This changes RRS 41.

# 14. CHANGE OF THE NEXT LEG OF THE COURSE

- 14.1 To change the next leg of the course, the race committee will either move the original mark (or the finishing line) to a new position, or the RC will lay a new mark and remove the original mark as soon as practicable.
- 14.2 The RC may adjust gate marks without further signaling to maintain the appropriate course configuration.

# 15. THE FINISH

- 15.1 The finishing line will be displayed between a staff displaying an orange flag on a Race Committee boat and the course side of a nearby mark, or between staffs displaying orange flags on two Race Committee boats.
- 15.2 Flag "A" displayed with no sound while boats are finishing means 'no more racing today.'
- 15.3 Flag "H" displayed with no sound while boats are finishing means 'racing will continue after a break either on shore or on the water.'
- 15.4 When neither Flag "A" nor Flag "H" is flying while boats are finishing, another race may follow immediately.
- 15.5 A boat that retires from a race shall notify a RC boat before leaving the racing area, or, if that is not possible, notify a regatta official at Regatta Headquarters immediately upon arrival on shore.

# 16. PENALTIES

RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

# 17. TIME LIMIT

- 17.1 The time limit will be 90 minutes.
- 17.2 Boats still racing 30 minutes after the first boat sails the course and finishes will be scored the position of the last boat to finish plus 2. This changes RRS 35 and A4.1.

#### 18. PROTEST AND REQUESTS FOR REDRESS

- A boat intending to protest about an incident that occurs in the racing area shall notify the RC finish boat of her intention, including the sail number of the boat(s) being protested. This changes RRS 61.1 (a).
- 18.2 Protests shall be written on forms available at Regatta Headquarters and delivered there within the protest time, which will end one hour after the signal boat docks. The docking time will be posted.
- Notices of protests and requests for redress will be posted within 20 minutes of the expiration of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held at a location at Regatta Headquarters.
- Notice of a request for redress including the nature of the request and the grounds on which it is filed shall be considered to fulfill the requirements of the prescription to RRS 63.2
- 18.5 On the last day of the regatta a request for reopening a hearing shall be delivered:
  - (a) Within the protest time limit if the party requesting reopening was informed of the decision on the previous day.
  - (b) No later than 30 minutes after the party requesting reopening was informed of the decision on that day.
  - (c) This changes RRS 66.
- 19.6 A boat that does not comply with 44.1 or 44.2, but prior to a hearing, acknowledges breaking a rule, shall be penalized 50% of the number of boats entered, but not less than six places, except that she shall not be scored worse than DNF, as approved by the Protest Committee.

# 19. SCORING

The Low Point System in Appendix A of the RRS will apply, except that RRS A2 is changed so that each boat's total score will be the sum of her scores for all races.

#### 20. RADIO COMMUNICATION

The only communication devices that may be used by competitors when racing are: (a) a weather monitor, (b) a VHF radio tuned to receive only RC transmissions that are intended for all boats (Competitor channel) and (c) a cell phone that may be used for emergency purposes only. The penalty for breaking this rule will be total disqualification from the regatta, or such lesser penalty as may be determined by the Protest Committee.

# 21. OUTSIDE HELP

A boat that receives outside help other than help permitted by RRS 41, or from a non-competitor or non-competing boat, shall retire. This changes RRS 41.

# 22. MEDIA RIGHTS

Competitors give absolute right and permission for video footage or photographs of themselves or their boat generated during an ILYA event to be published in any media for press, editorial or advertising purposes.

# COURSES W3 and W5 (Windward Finish)


W3 (3 legs- finish upwind): Start – W – OS - Gs/Gp - Finish

# COURSES L4 and L6 ("Dog Leg" Leeward Finish)

L4 (4 legs- finish downwind): Start - W - OS - Gs/Gp - W - OS - Gp - Finish

L6 (6 legs- finish downwind): Start - W - OS - Gs/Gp - W - OS - Gs/Gp - W - OS - Gp - Finish
