SYC Wooden Boat Invitational August 22nd, September 12th, 2015 NOTICE OF RACE

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).

Appendix T, Section A, T1 (One-Turn Penalty) shall apply.

The intended racing area will be the West of Alcatraz Area. Courses will be windward/leeward using inflatable dropped marks.

The First Warning will be at 1100 hrs on both dates. The August 22nd and September 12th dates are for Knarrs and or other fleets as per request. Three races per day are scheduled for Knarrs. The Bird fleet is scheduled for September with two races per race day scheduled.

For the Knarr Class SFBKA Articles Of Association will be in effect.

The low point scoring system RRS A4 shall be used. A minimum of one race shall be completed to constitute a series. All races count. This changes RRS A2.

Online entry is encouraged at: <http://www.regattanetwork.com/event/10176> or the entry form below can be used. The entry fee for the series is \$60 (Knarr), \$40 (Bird). Other fleets are \$40 per race day.

Sailing Instructions will be emailed to registered Skippers, and posted at the event website (<http://www.regattanetwork.com/event/10176>) as well as the club notice board by 1800 Thursday, August 20th. Results will be posted at the club notice board and on the event website after racing each day.

At the conclusion of the series, post racing September 12th, there will be hosted keg beer and hors d'oeuvres at the club. Series trophies for the Knarr Class will be awarded at that time. Other fleet trophies by prior arrangement.
