Dear 2015 U.S. Youth Match Racing Championship Competitors and Parents:

On behalf of US Sailing, our host Balboa Yacht Club, and our sponsors, we congratulate you on your invitation to the 2015 U.S. Youth Match Racing Championship for the Rose Cup. We have been planning for this event for some time, and we hope that you have a great sailing experience and that your stay in California will be a memorable one.

Our primary goal is to ensure that you and your team leave the event being a much more sophisticated and deadly match racer than when you came. To that end, we plan to give you a lot of coaching on Wednesday, June 17 and Thursday, June 18, which will also serve as a great way to get up to speed in the Governor's Cup 21's. And then we plan to lead a video debrief after Friday's racing. This will be in addition to the very useful umpire debriefs after racing as well. So, regardless of your present match racing experience and expertise, you will be much better at the end of the event.

Also, we are very excited that the Rose Cup is now a US Sailing National Championship. The event was first run in 2010 at the Balboa Yacht Club. It went "national" in 2012, and has been raced in St. Petersburg, Florida; Sheboygan, Wisconsin; and Oyster Bay, New York. It is fitting that the event is returning to its birthplace, the Balboa Yacht Club, for its first year as a true national championship!

This letter is designed to

- (a) be sure you are up to speed on all the details you need to know about the event; and
- (b) have you help us help you have a great event by sending us the information and forms we need to be prepared for you.

If you are the skipper, please forward this letter to each of your crew immediately.

ENTRY AND REGISTRATION; WAIVERS & OTHER PAPERWORK (attached)

To secure their spot in the event, Skippers must register and pay their entry fee online by May 8, 2015 on the event website at http://www.ussailing.org/racing/championships/youth/usymrc/. If you have not registered and paid by May 8, we may fill your spot from our waiting list.

Crews must register online by May 22, 2015.

Skippers should enter the first and last names of their crew and their e-mail addresses. Then they should click on EMAIL CREW. That will send a link to their registration page. Repeat the process for each crew member. It is the responsibility of the skipper to ensure the entire team is registered by May 22, 2015.

All paperwork must be submitted by either email or regular mail, **by May 22**, or within ten days of notification if you have come off the waiting list.

If any medical issues change, it is the responsibility of the parent/competitor to notify Becky Lenhart at 1.949.673.3515 x 133 as soon as possible. It is highly recommended that you bring a copy of your medical insurance card with you.

When you register, you will receive an e-mail receipt via Regatta Network. It is very important that you do not lose this. This link will allow you to go in and update your travel plans.



Make sure you enter the following information into your online registration:

Your personal e-mail (this is **not** your parent's, but yours)

Your **personal** cell phone number so we can reach you during the event

Your parent's e-mail (and it must NOT be the same as yours)

Your parent's phone number so we can contact them before or during the event

Your travel plans if known. Please do not enter flight information until you have purchased your ticket.

NOTICE OF RACE

Please review the NOR. It specifies all the financial aspects of the event, clearly states the rules concerning your behavior, and tells you when the event begins and ends so you can make appropriate departure plans.

Let me point out a couple of items from the NOR (but there are many more, so be sure to read them!):

- a) NOR 6.5(a) has been amended the refundable damage deposit will be \$1000 payable by credit card
- b) NOR 7.3 Every competitor must have turned at least 16 in 2015, and cannot turn 21 in 2015... Attach a PDF copy of your driver's license, birth certificate or passport to your online registration by May 22, 2015. NO EXCEPTIONS
- c) NOR 5.7 -All participants will need to get an **ISAF Sailor ID** by registering online at www.sailing.org/isafsailor. This is free and only takes a couple of minutes. Sailors will need to provide their ISAF ID# when they register online. This is so you can begin earning your ISAF Match Racing Ranking points.
- d) NOR 5.2 All participants need to be **current members of US Sailing at the time of registration and the regatta**. If you need to join or renew, go to www.ussailing.com/membership. You won't be able to register online if it's out of date. If you are unsure, you can check there too. Your user name and password are your US Sailing membership number.
- e) NOR 10.1 you need to sail with three (3) or four (4) people in the boat, and the total weight of all of you can't be more than 578 pounds (dressed in a T-shirt and shorts). Check your weights a week before you come! You don't want to have to go for a run while others are going for a sail! You only need to weigh in once, when you register at the event; there are no subsequent weigh-ins. Note: in keelboats, it is generally advantageous to be as close to max weight as possible.
- f) NOR 19 describes the dress code for the event. You do NOT need to bring a coat & tie or skirt.

ARRIVAL AND DEPARTURE (See NOR 22)

Competitors may arrive at the Balboa Yacht Club on Tuesday, June 16, between noon and 9:00pm, or on Wednesday, June 17. Attendance at the Awards Ceremony on Sunday, June 21, is **mandatory**, unless prior permission has been given by Dave Perry. Permission will be granted only in unusual circumstances. On Sunday, June 21, departing flights should not be scheduled from Orange County Airport (SNA) or the Long Beach Airport (LGB) **before 6:30pm**, or from the Los Angeles Airport (LAX) **before 8:00pm**.

PLASE ENTER YOUR TRAVEL PLANS ONLINE BY MAY 22



Once you have registered online, you will receive an email from Regatta Network with a link to add your travel plans. It is imperative that you enter your arrival and departure details **no later than May 22**. You can use this link to update/change your plans at any time prior to this deadline. After May 22, you must email any changes immediately to Becky Lenhart, BYC Sailing Director: sailing@balboayachtclub.com

It is imperative that regatta organizers receive accurate travel information for every participant. Please do not enter flights on the registration form until they have been booked and confirmed. Even if a sailor does not require airport transportation or regatta housing, we need to know their travel plans.

UNITED AIRLINES DISCOUNT

US Sailing has negotiated a discount code from United Airlines for travel to the 2015 championships. The website to apply our discount is http://www.ussailing.org/membership/benefits/.

This must be done through the US Sailing website; it cannot be done either through a travel agent or using the regular United website.

AIRPORT INFORMATION

There are three choices of airports to fly in and out of. The Los Angeles International Airport (LAX) is approximately a 55 minute drive to BYC. The Long Beach Airport (LGB) is approximately 35 minutes; and the John Wayne, Orange County Airport (SNA) is approximately 15 minutes.

BYC will arrange for pick-ups from SNA. BYC may be able to assist with pick-ups from LGB. Becky Lenhart will be in touch with competitors flying into either of those airports. Once we learn the competitors' departure plans, Becky Lenhart will be in touch with plans for getting to the airport on Sunday afternoon, June 21.

Competitors are on their own to get from LAX to the Balboa Yacht Club. Two shuttle companies are listed below.

TRAVEL DELAYS

SAILORSHIPS

This program is for sailors ages 13 to 18 and offers grants for sailors to travel to US Sailing's U.S. junior or youth championships. (Please note that class championships are not US Sailing events.) Sailorships will be awarded in amounts varying from \$100 – \$500 per person per year, based on need. Awards may be requested prior to or after an event, but only one award per year may be granted. Complete applications must be received by June 1 or October 1 for the calendar year. For more information go to: http://www.ussailing.org/racing/championships/youth/sailorships/

ON SITE CHECK-IN AND REGISTRATION

Registration will be open on Wednesday, June 17th from 1200 – 1700 hours. Upon arrival at BYC, proceed directly downstairs to the Sailing Director's office where Becky Lenhart will review that all forms have been correctly submitted.

Your life jacket will be inspected at registration. **Bring the USCG approved PFD that you plan to wear during the event.** Please refer to NOR 16 for the requirements.



If you are not staying in regatta-provided housing or your own home, the responsible adult named in your Alternate Housing Form must appear with you at registration.

Please have a credit card with you to pay for the damage deposit (\$1000) at registration; see amended NOR 6.5.

HOUSING

You will be notified of your housing placement at registration. Please remember that you will be a guest in someone's home, so please no wet towels on the floor, clothes everywhere, special meal requests or the like. Competitors will be separated by gender. When you learn your housing host's name, address, email and phone number, please give that information to your parents as soon as possible.

MEALS

Dinners will be provided throughout the regatta (Wednesday through Saturday). Breakfast will be provided by your host. **Competitors are on their own for their lunches and water**.

DRIVING TO THE VENUE

A Driver Release form signed by a parent or guardian must be on file for all sailors intending to drive a car to the venue. Parking will be on the street near the Club.

EVENT SCHEDULE and AWARDS CEREMONY

Attendance at all post-racing dinners and events at the USYMRC, including the Awards Ceremony on Sunday June 21st in the afternoon, is MANDATORY for all competitors.

COACHING / SPECTATOR BOATS

This event is a Grade 2 event as defined in the US Sailing Coaching and Support Boat Policy (see NOR 20). There will be US Sailing-supplied coaching, and OA-provided spectator boats. Private coaches and private spectator boats are not permitted in the racing area. It is our intent to provide a spectator boat for those wishing to go on the water on race days. Spectators will be requested to sign up at least the day before they want to go on the water. Space may be limited. Spectator boat sign up will be at the Balboa Yacht Club Sailing Director's office. Spectators are reminded to bring their own water, lunch and personal flotation devices. No alcohol will be allowed on the spectator boats.

SAILING INSTUCTIONS

Sailing Instructions will be distributed at registration and preliminary Sailing Instructions will be posted online on the event website.

WEATHER

The average air temperature in June is 68 degrees, with a low chance of rain. The average water temperature is 62 degrees. The average wind speed is around 6 knots.

ALCOHOL and DRUGS

US Sailing Regulation 10 is in effect from the moment you arrive at the venue in any capacity until the moment you leave the venue either for the airport or to drive home. The use of alcohol or any illegal drug by a competitor will not be tolerated during this period. Offenders will be dealt with strictly as stated in NOR 17 and the US Sailing Code of Conduct.

CURFEW

There will be a 10pm curfew during the event, meaning that ALL competitors, whether being housed or staying in their own homes, must be "home" where they are being housed by 10pm each night. This curfew is in effect from Wednesday, June 17 through Saturday, June 20. There will be no exceptions. We are not trying to make the event less fun; we are simply concerned for your safety.



CHRIS LOVE VIDEO

We are once again very fortunate to have Chris Love videotaping the event on behalf of US Sailing. Chris does a sensational job and is well known as the host of the Intercollegiate online show "Chalk Talk". Chris will video the racing each day, and then post his highlight show early the next morning for your family and friends' (as well as your) viewing pleasure. The link to the YouTube site with his postings will be on the event website, where you can also find the link to the results and press releases, etc.

TREATING THE HOST SITE PROPERLY

The US Sailing Match Racing Championships Committee and the Balboa Yacht Club have been planning and working on this event for quite a while. We take the U.S. Youth Match Racing Championship very seriously as the premier youth match racing regatta on the 2015 US Sailing calendar, and you can be assured that we have planned the best possible event for you. As our guests, we hope that you appreciate our efforts. You are expected to follow all of the Balboa Yacht Club rules at all times. Please be as self-sufficient as possible and help others as needed. We expect that you will jump in and help without being asked!

PERSONAL GEAR

Mark all your belongings in advance! We continually find clothes and equipment that competitors leave around throughout the event. All items with a name clearly on them usually get returned. Take a few minutes with an indelible marker and put your name on everything you will be bringing.

WE SUGGEST THAT YOU BRING THE FOLLOWING:

- USCG approved PFD that is the right size for your height and weight. NO EXCEPTIONS
- Your refillable water bottle labeled with your name. This will be a green regatta.
- Sunscreen, sunglasses, hat, and rash guard (for sun protection)
- Notebook, pen, Rulebook
- Personal entertainment (e.g. books, iPod, etc.)
- Appropriate sailing gear and clothing for the conditions
- A small sailing bag with electrical tape (no black please), telltale material, short pieces of spectra or other strong line, and a couple of shackles and ring dings, etc. IF you are going to bring a Leatherman or some sort of knife, be sure you pack it in your suitcase and not in your carry-on bag where it will likely be confiscated at the airport.

We are looking forward to seeing you in a few short months, for five days of great training and competition!

US Sailing Championships

Code of Conduct



Introduction

Each competitor in a US Sailing Championship or Qualifier hereby pledges to uphold the spirit of this US Sailing Code of Conduct (Code). This Code is not intended to establish a set of rules that will, by inclusion or exclusion, prescribe the appropriate behavior for competitors in every aspect of their participation in a Championship or Qualifier. Rather, the Code offers general principles to guide the conduct of competitors in situations that have ethical implications.

The competitor commits to familiarization with this Code and understands that acceptance of its provisions is a condition of participation in a US Sailing Championship or Qualifier.

Competitors who do not conform to this Code will be subject to the consequences of their actions, as specified below. The competitor has a right to a hearing if charged with a violation of this Code.

Elements of the Code

Each competitor in a US Sailing Championship pledges he or she:

Participation

> Will abide by *The Racing Rules of Sailing*, the US Sailing Regulations, all rules related to the Championship selection procedures as specified by US Sailing, the Championship Conditions, the Notice of Race and the Sailing Instructions for the Championship or Qualifier.

> Are eligible to compete under all US Sailing rules.

Fair Play and Conduct

Will abide by Rules 2 and 69 of the Racing Rules of Sailing.

Drugs & Alcohol

> Will abide by US Sailing Regulation 10.03 for Prohibited Substances as defined below:

> For adult US Sailing championship events, no competitor shall use, either on or off the water: marijuana or any other controlled substance as defined by state or federal law.

> For Junior and Youth events or for junior or youth competitors in any US Sailing championship, no participant or competitor shall use, either on or off the water, marijuana or any other controlled substance, or alcoholic beverages as defined by state or federal law.

Sexual Abuse & Harassment

Will abide by US Sailing Regulation 13.04 for Sexual Abuse & Harassment.

Physical Abuse & Assault

Will abide by US Sailing Regulation 13.05 for Physical Abuse & Assault

Bullying & Hazing

Will abide by US Sailing Regulation 13.06 for Bullying & Hazing.

Enforcement of the Code

> Compliance with this Code depends primarily upon understanding and voluntary compliance, secondarily upon reinforcement by peers, and, when necessary, upon enforcement through disciplinary action.

> If a competitor has been alleged to have violated this Code, the competitor will be given two options:

Voluntarily withdraw from the Championship or Qualifier where the violation occurred. The competitor shall be scored RET in all races sailed and not sailed. A report will be sent to US Sailing. If the offense warrants, further action will be taken pursuant to Rule 69

or

A hearing will be held and if the Code is determined to have been broken, the hearing panel has the authority to remove the athlete from the venue immediately and mark all races as DSQ. Further action may be taken if needed pursuant to Rule 69.

> Before making a decision whether to withdraw from the Championship or Qualifier, or to request a hearing, the competitor will be given the opportunity to consult with an individual of their choice before racing commences, in order to better understand their options and potential outcomes.
