



**Santana 22 National Championship Regatta
July 17th, 18th, & 19th, 2015
NOTICE OF RACE**

1. RULES

1. The race will be governed by the rules as defined in *The Racing Rules of Sailing*.
2. RRS 40 will be deleted but not its prescription and replaced with: "Competitors shall wear personal flotation devices at all times while afloat, except briefly while changing clothing or personal equipment."
3. The sailing instructions will change RRS 44 to require a one turn penalty.

2. ELIGIBILITY & ENTRY

1. FEES: The entry fee is \$125 per boat on or before July 17, 2015. Fee includes all racing. On Sat night for competitors pizza, salad and beer.
2. Competitors shall register in advance by completing the Event Registration Form found on <http://www.regattanetwork.com/event/10600>

3. SCHEDULE OF EVENTS: Racing and Social

1. **Friday** July 17:
 1. 10am Registration & check-in.
 2. 2pm Optional Practice Races 2pm First Warning (short courses). Two races scheduled.
2. **Saturday** July 18:
 1. 11:55am First Warning; Three races scheduled with a short break in between.
 2. 6:00pm Class meeting.
 3. 6:30pm Dinner (incl. in fee for all competitors: Pizza, salad and beer)
3. **Sunday** July 19th:
 1. 11:55am First Warning; Two races scheduled with a short break in between.
 2. Awards presentation after racing.

4. SAILING INSTRUCTIONS: The sailing instructions will be available at <http://www.regattanetwork.com/event/10600> no later than July 15th.

5. COURSES AND LOCATION:

1. Races shall be sailed in San Francisco Bay.
2. The start and finish line will be located in the Knox area west of Angel Island. Courses will be windward leeward, using inflatable temporary marks.

6. **COMMUNICATIONS:** The Race Committee may use the VHF 71 radio to communicate information about time to start and recalls.
7. **SCORING:** A maximum of 5 races are scheduled of which 3 shall be completed to constitute a series. No throw outs for this series. Practice race scores are excluded.
8. **SAFETY:** A boat retiring from a race shall notify a Race Committee before leaving the course by VHF, or as soon as reasonably possible thereafter.
9. **PRIZES:** Keeper Trophies first through fifth place and Class Perpetual Trophies will be awarded .
10. **DISCLAIMER OF LIABILITY:** Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority, CYC will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
11. **INSURANCE:** Each participating boat shall be insured with a valid third-party liability insurance policy.
12. **LAUNCHING:** After a boat launches it shall stay in the water until the end of the event.
13. **DOCKING & PARKING (following is not part of the NOR)**
 1. Participants are invited to use CYC guest dock and raft up in the harbor to the east of the Club. If you wish to extend your stay to the day before and/or the day after, you must coordinate with the Harbormaster.
 2. Corinthian Yacht Club has one hoist available to competitors to launch their boats.
 3. Paid parking is available for vehicles and trailers in Tiburon.
 4. Trailers may be stored in the in local parking lots outside the Club parking area.
 5. Due to limited space and Club rules, non-member trailers and vehicles may not be left or parked at CYC except during the actual transfer of the boat to and from the water.
