Rules

The race will be governed by the ISAF Racing Rules of Sailing, 2013-2016 (except as may be changed by the Sailing Instructions of this race). Class rules will apply. Sailing Instructions will be made available at registration and online.

Eligibility

Classes will be Portsmouth Handicap spinnaker, Portsmouth Handicap non-spinnaker and F-18. All spinnaker boats with will also compete in an overall Portsmouth Handicap corrected class. All boats must have a Portsmouth D-PN number lower than 77.6. Portsmouth Handicap crew weight corrections will not be used.

Courses

Legs each day will be between 20-50 miles depending on forecast conditions. Courses will consist of rounding various islands and government or Race Committee (RC) marks and will require a waterproof chart of Narragansett Bay, upper Mt Hope Bay and Sakonnet River south to/around Aquidneck Island and out to Point Judith. You must be able to navigate using charts and a compass or GPS. Courses will be made available online no later than August 7, 2015.

Prizes

Prizes will be awarded based upon the number of entries received through August 7, 2015. 10 or more entries, top three. Fewer than 10, top two. Equal prizes will be awarded to both skipper and crew in double handed classes.

Volunteers

The event is staffed by NECSA volunteers.
