#### RULES

The Regatta shall be governed by The Racing Rules of Sailing 2013-2016, the prescriptions of US SAILING, and the class rules of the United States Sunfish Class Association.

#### CLASS

Any Sunfish boat complying with United States Sunfish Class Rules.

#### ELIGIBILITY AND ENTRY

The event is a bring-your-own-boat regatta open to all participants and any sunfish boat complying with United States Sunfish Class Association. Sailors must be a member of a yacht club belonging to the NJYRA.

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$100,000 per event or the equivalent thereof. Proof of liability insurance must be provided at the time of registration. Proof of insurance can be obtained from your insurer with a separate statement of binding coverage. You must provide a copy at registration.

#### **ENTRY AND FEES**

Entry shall be made by completing the entry form available at US Sailing Regatta Network at http://www.regattanetwork.com/event/10745 and paying the entry fee of \$35 per sailor. Under 18 years of age junior entrance fee will be \$25.00. The skipper of each boat shall be charged a \$5.00 surcharge if not a US Sailing individual or family member. Registering after noon EDT August 8, 2015 will incur a \$5.00 surcharge.



**SAILING INSTRUCTIONS:** The sailing Instructions shall be available at registration and may be posted on the SBYC web site at www.spraybeachyc.org.

**MEASUREMENT:** All boats may be inspected throughout the event for class rule compliance.

**SCORING & RACE RESULTS:** The Low-Point Scoring System, Appendix A of the racing rules, shall apply. Race Results will be posted online shortly after the regatta at http://www.regattanetwork.com/event/10745

### SPECIAL REQUIREMENTS

- **PFD**-A personal floatation device shall be worn, properly fastened, from dock to dock by competitor while launching and when sailing, except briefly while adjusting clothing or equipment. - **BOWLINE**-A 14' x1/4" bow line must be secured to bow handle at all times.
