**NOTICE OF RACE**



## **1 RULES**

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*
- 1.2 The prescriptions that may require advance preparation by teams are stated in full below.  
The ISSA Procedural Rules and The Supplemental Rules of the PCISA
- 1.3 Class rules requiring CFJ or Club 420 class membership shall not apply.
- 1.4 All boats must use sails provided by Hawaii Youth Sailing Association (HYSA) and enter in any designated round robin rotation.

## **2 ADVERTISING**

- 2.1 Under ISAF Rule 20.3 this is a no advertising event except that
- 2.2 Under ISAF Rule 20.4.1 ‘...The Organizing Authority of an event has the right to make use of the following spaces according to the following terms: ...’ Under this rule boats may be required to display advertising chosen and supplied by the organizing authority.

## **3 ELIGIBILITY**

- 3.1 The regatta is open as follows: Qualifying Schools from every member District are eligible for this event. A school qualifies when they meet ISSA Rule 1. ELIGIBILITY
- 3.2 Each school with a team must be a current member of ISSA. Each school may register as many full teams as desired.
- 3.3 Each team must be accompanied by a designated adult team leader—coach or chaperone—who must be identified at time of registration.
- 3.4 A team is comprised of a minimum of 4 sailors.
- 3.5 A school sending less than 4 sailors can request that its team be supplemented with local (Hawaii) sailors. The request for supplemental sailors must be made in writing no later than 1700 hours HST Thursday 12 November 2015.
  - 3.5.1 The team requesting supplemental sailors will be responsible to pay the full Entry Fee and Damage Deposit.

## **4 REGISTRATION AND ENTRY**

- 4.1 Registration for teams may only be made by completing online forms at:

4.3 Required fees are per team. Schools with multiple teams will pay all fees below for each team and complete separate entry forms.

Entry Fee and Charter \$400.00

Damage Deposit Credit card information with payment of up to \$500

4.3.1 The Entry Fee includes charter boat and sail, breakfast and lunch on Saturday and Sunday, five (5) IMU Luau tickets, and five (5) regatta t-shirts

4.3.2 The Entry Fee must be paid by credit card on the Event Website at the time of registration.

4.3.3 Additional tickets for the IMU Luau and t-shirts can be purchased on-line at the time of registration.

4.4 A completed entry is defined as registration being completed on-line no later than 1700 hours HST on 12 November 2015 and all appropriate forms having been received by HYSA no later than 1700 hours HST on 20 November 2015. Exceptions may be made at the discretion of HYSA.

4.5 No refunds of the entry fee will be made after 21 November 2015.

4.6 Teams unable to compete must notify HYSA c/o Jill Tsuchitori as soon as possible.

4.7 Availability of entries, additional Luau tickets, and t-shirts, is on a first-come, first-served basis.

## **5 SAFETY & LIFEJACKETS**

5.1 Lifejackets meeting U.S. Coast Guard regulations for Personal Floatation Devices (PFDs) Type III shall be worn. Non U.S. Coast Guard certified PFDs will not be allowed.

## **6 FLEET**

6.1 The regatta will consist of one Fleet, with an A and B Division, and races will be sailed in Club FJs.

## **8 SAILING INSTRUCTIONS**

8.1 Sailing Instructions will be available by Friday 27 November 2015 at Check-in.

## **9 SCORING**

- 9.1 The regatta will be scored in accordance with Official Procedural Rules for Interscholastic Sailing Competition.
- 9.2 Three (3) races must be completed to constitute a series.
- 9.3 A full rotation will be desired, so that between the two divisions there will be approximately 6-10 races total per day, depending on the number of teams.

## **10 VENUE**

- 10.1 The host club will be Kaneohe Yacht Club.
- 10.2 The venue will be the waters of Kaneohe Bay directly to the west of the yacht club outside the coral patches that line the entrances to the harbor.
- 10.3 Practice session will be at Kaneohe Yacht Club. Please let us know if you intend to practice.

## **11 COURSES**

11.1 Courses will be Windward-Leeward variations detailed in an attachment to the Sailing Instructions.

## **12 PRIZES**

- 12.1 Prizes will be given at the end of the regatta to 1<sup>st</sup>-3<sup>rd</sup> place teams in the series scores.
- 12.2 Additional fun prizes may be awarded.
