THE CINCO DE MAYO REGATTA IS A ONE DESIGN REGATTA OFFERED FOR MULTIPLE ONE DESIGN CLASSES

THE NEUSE YACHT RACING ASSOCIATION IS THE ORGANIZING AUTHORITY

THE REGATTA WILL BE GOVERNED BY THE 2013-2016 RACING RULES OF SAILING. ALL BOATS SHALL COMPLY WITH N.C. WILDLIFE COMMISSION AND U.S. COAST GUARD SAFETY REGULATIONS.

EXPECTED ONE-DESIGN CLASSES (SJ21, SUNFISH, FJS, TANZERS, 420S, ENSIGNS, ETC.) WILL RACE EITHER IN BROAD CREEK JUST OFF BLACKBEARD SAILING CLUB, OR ON THE NEUSE RIVER JUST OUTSIDE THE MOUTH OF BROAD CREEK. MULTIPLE RACES ARE PLANNED.

FLEETS. A MINIMUM OF THREE BOATS WILL CONSTITUTE A FLEET. EACH FLEET MAY BE BROKEN INTO MULTIPLE CLASSES, INCLUDING DIVISION INTO SPINNAKER AND NON SPINNAKER CLASSES, DEPENDING ON INTEREST AND THE NUMBER OF ENTRIES. DIVISIONS WILL BE MADE AT THE SOLE DISCRETION OF THE PRINCIPAL RACE OFFICER.

AWARDS. A VALUABLE PRIZE WILL BE GIVEN TO THE WINNER OF EACH FLEET, OR IF A FLEET IS DIVIDED INTO CLASSES, TO THE WINNER OF EACH CLASS WITHIN A FLEET. ADDITIONAL AWARDS MAY BE GIVEN BASED UPON BOAT TURNOUT IN EACH FLEET. A FIESTA IS PLANNED AS A PARTICIPATION PRIZE FOR ALL RACERS AND THEIR GUESTS AS SOON AS PRACTICAL AFTER RACING IS COMPLETED.
