

2016 Laser Series Notice of Race

Organizing Authority: Tahoe Yacht Club

1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 Rule 40 will be changed as follows: Competitors shall wear personal floatation devices, except briefly while changing or adjusting clothing or personal equipment. Wet suits or dry suits are not personal floatation devices. Flag Y may or may not be displayed.
- 1.3 Except when violating the restricted start/finish line Sailing Instruction, rule 44.1 will be changed as follows: A boat may take a One-Turn Penalty as described in rule 44.2 when she may have broken a rule of part 2 while racing.

2 ADVERTISING

3 ELIGIBILITY AND ENTRY

- 3.1 This is a one-design regatta open to class legal boats.
- 3.2 Laser Standard Rigs, Laser Radial Rigs, and Laser Picos are eligible.
- 3.3 Laser Standards and Laser Radials may select either rig for any race.
- 3.4 Three boats must be registered to qualify for a start.
- 3.5 The TYC will be using Regatta Network this year. Eligible boats may enter online at any time: http://www.regattanetwork.com/event/12663

7 VENUE

- 7.1 The racing areas will be near Tahoe City between Dollar Point and Tahoe Tavern with the start off the US Coast Guard Station.
- 7.2 The courses will be around drop marks set by the race committee as described in the sailing instructions.

8 LAUNCHING AND BERTHING

Launching will be available at the Tahoe City Public Utility District launch ramp adjacent to the US Coast Guard station in Lake Forest, near Tahoe City. Boat storage on a Tahoe Yacht Club rack is available at same site for \$75 for the season or prorated for a shorter time period. 9 PRIZES

For each race night in the Series (Spring & Summer), will be awarded to a boat placing first, second, or third in each class provided there are at least five boats in such class. If there are fewer than five boats in a class, the number of prizes may be reduced for that class. The sponsors for this event are Jakes, Sunnyside, Moe's and Tahoe Yacht Club. Awards will be given each night at the sponsor's place of business. Location will rotate throughout the season and most sponsors provide for a free first drink!
