Santa Monica Bay
Saturday March 4, 2017
Sailing Instructions**

Amended 3/3/17

1 RULES

- 1.1 This race shall be governed by the "rules" as defined in the 2017-20 Racing Rules of Sailing (RRS).
- 1.2 PHRF So. California Rule #8 (Marine Industry Racer) does not apply. Individuals that satisfy the definition of "Marine Industry Racer" may not steer a boat in the Cruising Division.

2 NOTICES TO COMPETITORS

Notices to Competitors will be posted by 0900 race day each race day on a bulletin board inside the DRYC Clubhouse and may be downloaded at DRYC.org.

3 SCHEDULE; CLASSES AND CLASS FLAGS

- 3.1 There will be no Skippers meeting race day.
- 3.2 Class flags and the order of starts will be posted no later than 0900 race day.
- 3.3 There will be no Check In.
- 3.4 The Warning Signal for the first start will be at 1155.

4 COURSE AND MARKS

From the starting line:

All Divisions– PHRF, Cruising and ORCA Classes

- a. Round the Santa Monica Bay Waverider Buoy 028 located at approximately 33° 51' 16" N and 118° 37' 57" W, leaving the mark to port.

- b. Proceed to the finishing line.

5 THE START

- 5.1 The starting area will be in the vicinity of MDR H Mark (see MDR Course Chart 17).
- 5.2 The starting line will be between an **Orange** inflatable mark and an **Orange** flag on the RC boat at the opposite end.
- 5.3 The Starting Signal for a class will be the Warning Signal for the next class. This changes RRS 26.
- 5.4 The RC will attempt to announce starting information and recalls on VHF 68.

6 THE FINISH

- 6.1** Entering the south entrance of the harbor, the finishing line will be between the green light on the south end of the detached breakwater and an orange flag on the RC boat (anchored behind the detached breakwater).
- 6.2** Note your finish time (GPS) and boats that finish ahead and behind.
- 6.3** The RC boat intends to be on station until 2030. If the RC boat is not on station, record your finish time (GPS) when the green light on the south end of the detached breakwater bears 200° from your bow.
- 6.4** **If approaching the finishing line after dark**, boats shall notify the RC boat on VHF 68 as they approach the breakwater and shall shine a light on their sail number as they finish.

7 PROTESTS

- 7.1** Boats shall notify the RC of their intention to protest within two hours after finishing, either in person at DRYC or via the contact phone number in **SI 12**.
- 7.2** Protests shall be filed at DRYC no later than 1200 on the day after race day (Protest Time Limit). Hearings will be scheduled for a later date.

8 HANDICAP RATINGS / SCORING

- 8.1** The handicap course length for the all Divisions is 21 nm.
- 8.2** PHRF of So. California Area B RLC ratings and MDR RLC Certificated Cruising Class ratings will apply
- 8.3** ORCA Time Correction Factors (TCF) will apply.

9 TROPHIES

There will be a trophy presentation with complimentary hors d'oeuvres and a no-host bar at DRYC after the race. Trophies will be awarded for first to third in each class.

10 RADIO COMMUNICATIONS

The RC will attempt to monitor and announce starting information and recalls on VHF 68.

11 CLUB FACILITIES

Participants are welcome to use DRYC club facilities on race day.
