• Each Snipe racing in this event must have aboard life-saving equipment conforming to government regulations in either the USA or the home country of each of the sailors aboard.

ADVERTISING: Advertising is permitted as per snipe Class Rules. Boats may be required to display

advertising chosen and supplied by the organizing authority.
