## **Jaws Race (Predicted Log)**

### **NOTICE OF RACE & ENTRY FORM**

**Saturday March 25, 2017; Start between 1230 and 1300 hours**

**Start and Finish off the Club Deck**

The Sausalito Yacht Club invites Bay Power Boaters to come out for the annual "Jaws race." The race consists of a "Predicted Log" race with the start and finish off the deck of the Sausalito Yacht Club. The intent is to have about a two hour course around fixed marks in San Francisco Bay. Minimal instruments for navigation and timekeeping are permitted. See the "Rules" below.

A "Pursuit" race for sailboats will be running concurrently with this race for powered boats. Senior member Bud Livingstone has created this race to bring back the old club tradition of starts and finishes off the club deck. The "Jaws" trophy has been donated by Bud.

Entry is open to power yachts with the following requirements: an inboard power plant (including I/O's), permanent head, permanent galley, permanent bunks and operates at a speed between 5 and 10 knots. Sailboats under power meeting the entry requirements are also eligible.

A boat may start at any time between 1230 and 1300 hours.

**RULES:** Powered boats will be governed by 72 COLREGS and the Racing Instructions. Time predictions for rounding each waypoint on the course are due to the race committee prior to starting on March 25. Instruments allowed while competing are a tachometer, compass, fathometer and "through the water" speedo. A GPS or other device used to display speed over ground and a timepiece are **not** allowed for navigation. A timepiece is required for the on-board time recorder only.

The lowest absolute time difference of the sum of the time differences at each of the waypoints will determine the winners. Waypoints will be stated in the Racing Instructions.

Trophies will be awarded after the race. Some hosted hors d'oeuvres and beverage will be provided as it lasts for participants after the race. The "Jaws" perpetual trophy will be presented to the winner – and to the winners of the concurrent Pursuit race for sailboats – after the event.

A non-mandatory Skipper's Meeting will be held at 1800 hours March 15<sup>th</sup> at the club.

The Entry fee is waived for SYC club members and is \$30 for non-members. All entries are to be received, at the club or online, by 1200 hours on Saturday March 25<sup>th</sup>.

Racing Instructions, including waypoints, will be posted on the club website and available at the club no later than Wednesday March 15<sup>th</sup> at 1800 hours. Results will be available after the race at the club and posted on the club's race bulletin board and web site as soon as practical.
