

NOTICE OF RACE

South Coast Corinthian Yacht Club is invites all PHRF, One-Design, Cruisers and ORCA boats to the annual event honoring SCCYC Commodore, Les Storrs, 1936. 1. RULES

- 1.1 This regatta shall be governed by the 2017-2020 Racing Rules of Sailing (RRS).
- 1.2 PHRF, ORCA and One design classes will be subject to the rules of their respective class.
- 1.3 RRS V1 (one turn penalty for incidents outside the zone of a non-starting mark) will apply.
- 1.4 RRS Appendix A 2.1 is amended, no race scores will be excluded. All scores will count.

2. ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all keelboats, center board and multihull boats.
- 2.2 Entrants must be a member of a yacht club or sailing association belonging to SCYA or US Sailing.
- 2.3 Entrants in PHRF or ORCA classes must have a 2017 PHRF Certificate or 2017 ORCA Rating. Cruisers need a 2016 ASMBYC Cruiser rating or 2017 MDR Cruiser rating. All Cruiser ratings are at the discretion of the RC.
- 2.4 Registration is online at <u>www.regattanetwork.com/event/14099#_home</u>.

3. CLASSES

- 3.1 Classes will be established based upon the number of entrants as of 0900 on race day.
- 3.2 Three boats or more will establish a class. Five boats in a class will get a separate start. One-Design classes are encouraged to have a representative contact PRO, Bruce Fleck at 310-600-5214 or SCBruceFleck@gmail.com.

6. SAILING INSTRUCTIONS

- 6.1 The Sailing Instructions (SI) and Course Charts will be available online at <u>SCCYC.org</u> and <u>RegattaNetwork.com</u> least one week before the regatta.
- 6.2 Notice to Competitors will be posted no later than 1100 race day on the exterior wall of SCCYC Club building's main entrance and below its mail box.

7. VENUE

- 7.1 This regatta will utilize the Marina del Rey Course Chart 17 marks Southwest of the MDR Breakwater.
- 7.2 Attachment **2017 Les Storrs Course Chart** shows the location of the racing area.

8. COURSES

- 8.1 PHRF and One-Design will be Windward / Leeward courses chosen from **2017 Les Storrs Course Chart.**
- 8.2 Cruiser and ORCA will be Random Leg Courses chosen from **Cruiser Course Chart.**
- 8.3 Classes may sail a different number of races, as requested by class representatives, and as the weather allows.
 The RC hopes to run four races and finish racing by 1700. Cruising / ORCA Classes will run no more than two races.

9. SCORING

- 9.1 This regatta shall be scored as provided in RRS Appendix A.
- 9.2 RRS Appendix A 2.1 is amended, no race scores will be excluded. All scores will count.

10. PRIZES

10.1 Prizes will be awarded at SCCYC, as soon as possible after racing.

11. RADIO COMMUNICATIONS

- 11.1 Race Committee (RC) will monitor and can be contacted via Channel 68 for appropriate communications.
- 11.2 While on the water, changes in the SI, Course, or other communications may be announced by RC via Channel 68.

12. DISCLAIMER

12.1 Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

Docking: Limited docking is available at the most Northern dock at Fisherman's Village for up to four hours. Please contact SCCYC Race Chair, Mike VanLancker, for info.

Parking: Parking at SCCYC is within the Fisherman's Village Parking lot and will be validated for up to two hours. Please be sure to have your parking ticket validated! There is additional free parking available Dock 52 parking lot on Fiji Way. It's adjacent to the launch ramp and a short walk North of the SCCYC clubhouse.
