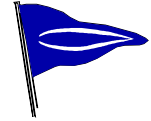

**Rendezvous:** At 1015 in vicinity of Region 1 Mark "O" (G"3" FI G 4s). Be alert for code flag "L".

**Radio:** Boats should monitor VHF 72 for courtesy communications from the Race Committee.

**Start:** The anticipated time of the first warning is at 1100.  
Between yellow flag on Race Committee boat and a Region 1 mark *OR* a temporary mark set by Race Committee. If a temporary mark is set, it automatically becomes Mark "Y" and may be used as a course mark. All boats must start within 15 minutes of their starting time.  
The second race will start immediately after the last boat has finished first race.

**Signals:** RRS 26 (Starting Races) as changed by: Starts will be offered for the following classes.  
PHRF A      PHRF N  
PHRF B      Multihull A<sup>o</sup> & B<sup>o</sup>  
PHRF C      Cruising  
<sup>o</sup> – Denotes event does not qualify for CBYRA High Point.

**Course:** CBYRA 2017 Drop Mark type course or Region 1 Standard Racing Marks designated by letters and numbers displayed on the Race Committee boat.

**Finish:** Between yellow flag on Race Committee boat and finishing mark. All courses may be shortened at any designated course mark.

**Time Limit:** 3 hours per race.

**Protests:** Verbally notify Race Committee boat of protest prior to leaving finish area. Mail protest forms, postmarked by Tuesday 17 October, 2017 with copies sent to protestee and Glenn Harvey, 3087 Scottsborough Way, Riva, MD 21140. Parties involved in protests will be notified of date, place, and time of hearing.

**Awards:** 1<sup>st</sup>/3, 2<sup>nd</sup>/5 & 3<sup>rd</sup>/7+ finishers. Prizes will be awarded on the basis of combined score for both races. Trophies will be presented at GSA Recognition Party in December 2016. Non-GSA members are invited to attend our party to receive their awards.

**Social:** Saturday evening, details and location to be announced prior to the race.
