# **Notice of Race & Sailing Instructions**

#### 1. RULES

- **1.1.** This event will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- **1.2.** Competitors will be well familiar with and adhere strictly to the "Basic Principles", the entirety of Part 2 "When Boats Meet", RRS 31 "Touching a Mark" and RRS 44 "Penalties at the Time of an Incident".
- **1.3.** The Lake Norman Keelboat Council (LNKC) Lakewide Sailing Instructions (LSI) and the LNKC Standard Sail Equipment Specifications will apply. LNKC documents can be found at <a href="https://www.lnkc.com">www.lnkc.com</a>.
- **1.4.** Competitors agree to be bound by all rules that govern this event.

#### 2. ELIGIBILITY

- **2.1.** The LSI will apply.
- 2.2. This is a Lakewide event.

#### 3. SINGLE HAND EVENT

**3.1.** This is a single-handed event. The only person on board will be the skipper.

#### 4. REGISTRATION & FEES

- **4.1.** Registration is available online via the Regatta Network at <a href="http://www.regattanetwork.com/event/14497">http://www.regattanetwork.com/event/14497</a> or by mailing in the Entry Form with proper payment.
- **4.2.** Registration is open from the posting of this Notice of Race & Sailing Instructions until 5PM of the day before the race.
- **4.3.** US Sailing Member Fee \$25.
  - **4.3.1.** Non-US Sailing Member Add \$5.
  - **4.3.2.** Late Registration Add \$5 if not paid by May 8, 2017.

#### 5. CLASSES

- **5.1.** There will be one fleet.
- **5.2.** A spinnaker may be flown at the discretion of the skipper.

#### 6. SCHEDULE OF EVENTS

**6.1.** Warning Signal – 10:25 am Saturday, May 13, 2017.

#### 9. THE START

- 9.1. The Class Flag will be the Numeral Flag 1. This changes LSI 10.1
- **9.2.** Course signals and any flag that makes part of Rule 30 applicable will be displayed separate from the starting sequence signals. This changes RRS 26 and the Preparatory Signals in Race Signals.

#### 10. SCORING

10.1. The PHRF Handicap System will be used and the Time on Time Low Point Scoring System will apply.

#### 11. PROTESTS AND REQUEST FOR REDRESS

- 11.1. Competitors are encouraged to resolve all protests on the water according to the Rules.
- 11.2. Protest will be lodged per the LSI instructions.
- 11.3. Scores will be posted but labeled as "Tentative" until any protests are resolved.

### 12. PRIZES

**12.1.** A Top Gun trophy will be awarded to the overall winner of the event. As there can only be one Top Gun, there can only be one award.

#### 13. DISCLAIMER OF LIABILITY

**13.1.** Competitors participate in the event entirely at their own risk. See Rule 4 – Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the event.
