### June 10 & 11, 2017 Notice Of Race

#### Rules:

The regatta will be governed by the rules as defined in the 2017 – 2021 Racing Rules of Sailing, the attached waiver and release of liability, the prescriptions of the United States Sailing Association, the by-laws and appendices of the Comet Class Yacht Racing Association (CCYRA) and the Sailing Instructions. (Anchor & line, paddle, and PFD's are required per CCYRA Specifications, Section 16.)

#### Eligibility, Entry and Waiver:

This event is open to CCYRA members who have paid their 2017 dues.

All registrations must be completed online at <a href="www.cometclass.com/regattas">www.cometclass.com/regattas</a> for this event. Payment options are: credit card, PayPal or check made out to CCYRA. (Send checks to Joe Lauver, 1841 Clarks Valley Road, Dauphin PA 17018 or bring to the regatta.) Online entries will be accepted until 5:00 PM on Wednesday, June 7. To reserve tickets for the steak dinner on Saturday night you must register by Saturday, June 3.

All participants will be required to sign a Waiver and Release of Liability Form at the registration table on Friday evening or Saturday morning.

#### Fees:

The <u>CCYRA 2017 North American Championship Regatta</u> entry fee is \$120. Included in the registration are all skipper and crew meals, additional meals for guests are available through the online registration form as follows: Lunch - \$6 each and Dinner - \$20 each. They can be paid for using a credit card, PayPal or check. Checks are to be made payable to: CCYRA.

#### Scoring:

This event has seven (7) races scheduled, tentatively with four (4) to be sailed on Saturday, June 10, three (3) on Sunday, June 11. One (1) race will constitute a series; if four (4) or more

races are sailed, each boats poorest finish will be discarded. [Sailing Instructions will be provided at the Registration Desk.]

#### Sail Measurement:

During the registration period all sails are subject to measurement and to checking for CCYRA Sail Tax Labels. [If you need Sail Tax Labels, contact Dave Seifert (614) 457-3094.]

#### Awards:

Finishes first through fifth will receive trophies for skipper and crew.

#### **Spectator Boats:**

Some spectator boats may be provided, but viewing is very good from the club deck.
