

1. RULES

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing 2017-2020*, the prescriptions of the US Sailing Association, the CFJ Class Rules, this Notice of Race, and the Sailing Instructions.
- 1.2. The Organizing Authority (OA) is the CFJ Class and Coronado Yacht Club. The event is hosted by Coronado Yacht Club.

2. ELIGIBILITY AND ENTRY

- 2.1. Teams shall sail in a fully measured boat of the CFJ Class.
- 2.2. Teams shall consist of two (2) people.
- 2.3. Members of a team shall be junior sailors under the age of 19 and who have not yet entered college.
- 2.4. Teams may enter by completing the following tasks:
 - 2.4.1. Complete the online entry by the close of the Entry Period (2400 hours Tuesday, July 25th, 2017).
 - 2.4.2. Download, print, complete, and present the [SDAYC Liability Waiver](#) to the Registration desk for each member of the team.
 - 2.4.3. Present a completed CFJ Nationals Equipment Inspection form to the Registration desk.
 - 2.4.4. Complete Team Weigh-In.

3. ADVANCED REGISTRATION & LUNCH ORDER

- 3.1. Competitors shall register online at regattanetwork.com.
- 3.2. Competitors may pre-purchase lunch from the CYC snack bar. Lunch includes Sandwiches come with fruit, big cookie and chips and individual condiments. Download the order form from juniors.coronadoyc.org.

4. FEES

- 4.1. The entry fee for entries received by 2400 July 14, 2017 will be \$150.
- 4.2. Entries received after 2400 July 14, 2017 will be a \$50 late fee making the registration fee \$200 and they may not receive an event shirt.
- 4.3. No entries will be accepted after 1700 hrs on Tuesday, July 25th 2017.

5. CORONADO YACHT CLUB RULES AND PARKING

- 5.1 **NO PARKING** in the club parking lot at any time! You may park in the south lot of the club or on the street at any time. CYC will have trailer parking in the dirt lot in side of the club parking lot for all trailers.
- 5.2 **NO boats or trailers can arrive before Thursday July 27th 8:00 am without permission by contacting Jill Powell jroffice@coronadoyc.org**

12. MEASUREMENT

- 12.1. Each boat must have valid measurement certificate on file with the CFJ class.
- 12.2. New boat measurements will be by appointment only on Thurs, July 27 between 9 and 11:30 am.
- 12.3. New boats, or older boats not previously measured by the class, must arrange for a measurement appointment with the class secretary to obtain a class measurement certificate.
- 12.4. For a measurement appointment contact Mette Segerblom, CFJ Class Secretary at (714) 609-2537, or cfjclass@gmail.com by July 20, 2017.

13. EQUIPMENT CHECK

- 13.1. Equipment check, hull and sail measurement for all boats entered in the regatta will take place on Thursday July 27, 2017 from 1200-1700 at the Coronado Yacht Club on a first come first serve basis.
- 13.2. All boats must obtain a CFJ Nationals Equipment Inspection form from the Registration Desk, and return the completed and signed form to the Registration Desk to complete regatta check-in.
- 13.3. Competitors will be weighed during regatta measurement. Each competitor shall be weighed dry wearing a t-shirt and shorts.
- 13.4. The combined minimum crew weight shall be 240 lbs. Crews not reaching minimum weight shall carry up to 25lbs of corrector weight as approved by the CFJ Class measurer.
- 13.5. Each competitor shall be responsible for their boat being in compliance with the class rules.

14. SAILING INSTRUCTIONS

- 14.1. The sailing instructions will be available on the CYC Juniors website (<http://juniors.coronadoytc.org/>) no later than 1700 hours Wednesday, July 26th.

15. VENUE

- 15.1. Racing will be conducted in the area known as South Bay. Tows will not be provided. Competitors are responsible for their own tows.

16. SCORING

- 16.1. Three races are required to be completed to constitute a series.
- 16.2. The Low Point System of Appendix A will apply except as modified below.
 - 16.2.1. When fewer than five races have been completed, a boat's series score will be the total of her race scores.
 - 16.2.2. When six or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
 - 16.2.3. When 11 or more races are completed, a boat's series score will be the total of her race scores excluding her two worst scores.

17. COACHING & COACH BOATS

- 17.1. Coaches must check in with the OA providing coach name, cell #, boat length and description no later than 1700 Thursday, July 27th.

- 17.2. Coaches must attend the coaches briefing immediately following the competitor's meeting on Friday, July 28
- 17.3. Coaches are expected to adhere to acceptable standards of conduct at all times during the event.
- 17.4. Coaches must provide their own VHF and monitor channels 16 and 69. Failure to comply to a RC hail will be grounds for removal from the course.
- 17.5. Coaches shall not give advice, instruction, or any other type of assistance during racing, except to render assistance to a boat in distress.

18. SAFETY

- 18.1. A USCG Approved Type III personal flotation device shall be worn, at all times while racing. Failure to comply with this rule will result in disqualification from all races sailed.
- 18.2. A boat retiring from a race shall notify a Race Committee vessel before leaving the course, or when that is not possible immediately upon returning to shore with the CYC Front Desk. Failure to do so shall result in a 10% scoring penalty for the last race sailed.
- 18.3. Should a boat be unable to safely make it to CYC from the racing area, the OA will provide regatta volunteers with an anchor so that the boat(s) in distress can anchor until a tow is available.

19. SPECTATOR & SUPPORT BOATS

- 19.1. Support must provide their own VHF and monitor channels 16 and 69. Failure to comply to a RC hail will be grounds for removal from the course.
- 19.2. Spectator and support boats over 20ft in length need to contact the CYC Dockmaster (619) 435-1848 to arrange for a berth for the event. **Berths are assigned on a first come, first serve basis and not guaranteed.**

20. DISCIPLINE

- 20.1. No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, or distilled spirits, each as defined in Chap 51 of the US Internal Revenue Code and intended for beverage use), or marijuana, cocaine, or any other controlled substance (as defined in 21 US Code 802), the possession of which, by that contestant is unlawful under 21 US Code 841. Infringements of this regulation and/or other discipline expectations occurring during July 25-28, 2013 may be the basis for a hearing under RRS 69.1. The protest committee for such a hearing shall be the regatta chairperson, a member of the ISSA BOD, and the protest committee chairperson. This protest committee shall, at a time and place selected by them, meet to hear said protest, and their decision to impose scoring penalties, or other sanctions they alone deem appropriate, including summary removal from the regatta, shall be final, without appeal.

21. PRIZES

- 21.1. The top finishing team will have their names engraved on the Warmington CFJ National Championship Trophy.
- 21.2. Trophies will be provided to the top 10 finishing skippers and crews and 2 race committee, special recognition awards that can be given to individuals or skipper and crew together.

22. DISCLAIMER OF LIABILITY

- 22.1. Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
