

2017 Gar Woods Regatta Notice of Race Organizing Authority: Tahoe Yacht Club

1 RULES

- 1.1 This race will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 Rule 40 will be changed as follows: Competitors shall wear personal floatation devices, except briefly while changing or adjusting clothing or personal equipment. Wet suits or dry suits are not personal flotation devices. Flag Y may or may not be displayed.

2 ADVERTISING

3 ELIGIBILITY AND ENTRY

- 3.1 This series is open to any keelboat or multi-hull with an LOA of 18 feet or greater.
- 3.2 Boats shall hold a current PHRF certificate from the Lake Tahoe PHRF Committee.
- 3.3 The TYC uses Regatta Network for regatta management. Eligible boats may be entered online not later than 1500 hours, 8/11/17: <u>http://www.regattanetwork.com/event/15300</u>.
- 3.4 Provided sufficient boats are entered, boats will be scored in the following divisions:
 - Division 1 (PHRF < 37)
 - Division 2 (PHRF >36 and <90)
 - Division 3 (PHRF >90)
 - Doublehanded
- 3.5 If fewer than four boats are entered in any division, the race committee may combine them with other divisions and score them accordingly.

7 VENUE

7.1 The racing venue will be on the waters of Lake Tahoe, off the shores of Gar Woods Restaurant in Carnelian Bay.

8 SCORING

Races will be scored using the Tahoe PHRF Handicap System with Time-on-Time scoring as described by US Sailing: <u>http://www.ussailing.org/racing/offshore-big-boats/phrf/time-on-time-scoring/</u>

TCF = A / (B + PHRF)Where A = 650 Where B will be assigned by the race committee:

B = 480 for heavy air, 550 for average conditions, 600 for very light air.

9 PRIZES

- 9.1 Prizes will be awarded based on entries.
- 9.2 Competitors are requested to attend the awards presentation at Gar Woods Restaurant shortly after the last boat finishes.

10 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Tahoe Yacht Club and any other organizing authority for the regatta will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

11 INSURANCE

Participating boats shall be insured with valid third-party liability insurance. Boat owners are solely responsible to ensure that such coverage is current and adequate.
