

# **NOTICE OF RACE**

# 27<sup>th</sup> Annual Carolina Keelboat One Design Regatta U20 East Coast Championship LAKE NORMAN YACHT CLUB

November 11-12, 2017

#### 1. RULES

The regatta will be governed by the rules as defined in The Racing Rules of Sailing 2017-2020 Edition (RRS).

# 2. ELIGIBILITY & ENTRY

This regatta is open to one-design keelboats. Eligible boats may enter the regatta by registering online. The Regatta is open to boats of the classes that register in accordance with the Notice of Race. Classes shall consist of not less than three boats.

# 3. REGISTRATION FEES

#### Fees:

- \$55 per keelboat. Late fee \$10 after 11/06
- \$12 Saturday Dinner; Limited dinners will be available at event.

All fees and meals should be ordered on-line if possible.

# 4. SCHEDULE

Racing will be Saturday and Sunday only. A maximum of seven races shall be sailed. No races will be started after 1400 hrs. on Sunday.

# 5. SAILING INSTRUCTIONS

Sailing Instructions will be posted on the Official Bulletin Board located at the Race Management Center. Copies will be available at registration.

# 6. THE COURSES:

Courses will be Windward-Leeward.

# 7. SCORING

Low Point System; Appendix A2 of the racing rules will apply, except that all races will be scored with no throw outs. One race completed, shall constitute a regatta. This changes RRS A2.

# 8. AWARDS

Trophies will be awarded based on number of boats registered by November 6, 2016:

# boats in fleet	trophies
3-4	1
5-6	2
7-9	3
10+	4

U20 East Coast Championship has a perpetual trophy for the 1st place finisher.

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

Boats wishing to stay at LNYC until the Keelboat Mid-winters (March 2018) must complete the LNYC Boat Storage Waiver prior to leaving LNYC. The waiver will be provided at Registration.
