Responsibilities of the Boat Owner

- Make their Shark available for the Sail Canada Women's Keelboat Championships 2018
- To provide the boat "race ready" prior to the inspection with the Dock Captain (a regatta representative responsible for turnover of boats)
- To remove all non sailing and personal equipment from the boat, other than mandatory safety equipment
- To be aware of the current condition of the hull, sails, all equipment and hardware on the boat
- To advise the Dock Captain of any issues, as soon as possible, prior to and after the event
- To provide deductible on insurance policy and a copy of insurance to MCC and the borrowing team
- To be available as owner or appoint a representative familiar with the boat to attend team orientation on Wednesday Sept 12th p.m. or Thursday Sept 13th am.

Responsibilities of the Skipper and Team borrowing the boat (to be completed no later than registration Sept 12 or 13th)

- To check over their Shark 24 for the Sail Canada Women's Keelboat Championships
- Attend the boat - team orientation with the boat owner or representative
- To be aware of the current condition of the hull, sails, all equipment and hardware on the boat
- To advise the Dock Captain of any issues, as soon as possible, prior to and after the event
- To ensure the damage deposit of \$500.00 (credit card) is deposited with the regatta chair/representative prior to obtaining the boat. If a deduction from the damage deposit is decided by the OA it may require the deposit be restored to its original amount before the skipper will be permitted to continue in the event.
- To be responsible for any and all damages to the borrowed boat provided that for insurable damage the responsibility is limited to the value of the insurance deductible
- To provide sailing resumes for all team members to the boat owner for his/her personal knowledge
- Teams may not modify boats or remove or attach fittings without approval of the owner or owner's representative. Equipment such as engines must remain in position as per class rules.
- Ensure the boat is clean and tidy when returned to owner
- Know and respect the "Sailors Oath"
