RULES:

- The Organizing Authority is Coconut Grove Sailing Club and Miami Snipe Fleet # 7.
- The regatta will be governed by the rules as defined in the Racing Rules of Sailing ("RRS").
- The following Prescriptions of US Sailing are the only Prescriptions that will apply: Appendix R and prescriptions to rules 60.3, 61.4, 63.2, 67 and 76.1.
- Each Snipe racing in this event must have aboard life-saving equipment conforming to government regulations in either the USA or the home country of each of the sailors aboard.
- The following Rules will be amended in the Sailing Instructions: RRS 27.1; RRS 30.4; RRS 32; RRS 33; RRS 35; RRS 44.3(c), RRS 61; RRS 62.2; 63.7RRS Appendix A2; RRS Appendix A4; RRS Appendix A5; RRS Appendix A11; and RRS Race Signals

ADVERTISING: Advertising is permitted as per Snipe Class Rules. Boats may be required to display advertising chosen and supplied by the Organizing Authority.

**ELIGIBILITY
AND ENTRY:**

The regatta is open to SCIRA registered boats and Class Member skippers who are in good standing with SCIRA for the current year. Boats shall enter the Regatta by completing the on-line registration and paying the entry fee on the event website: <http://www.regattanetwork.com/event/18030>. Full payment must be received for registration to be complete.

FEES: \$130.00 if received by 1800 hours on March 15th, 2019.
\$150.00 if received between 1800 hours on March 15th and 1800 hours on March 20th, 2019.
No entries will be allowed after 1800 hours on March 20th, 2019.
