# 1. RULES

1.1 The regatta is organized by the Mobile Yacht Club and will be sailed under the management of the Mobile Yacht Club Race Committee

#### 2. \*ELIGIBILITY AND ENTRY

2.1 The regatta is open to PHRF and Portsmouth Cruising Divisions.

2.2 The following restrictions on the number of boats apply: There must be 3 boats to make a class.

#### 3. FEES

3.1 Required fees are as follows:

3.5 \*The scheduled time of the warning signal for each day is 11:55

#### 4. SKIPPERS MEETING & SAILING INSTRUCTIONS

The skippers meeting will be at 1930 on 3/8/19 at Mobile Yacht Club

The sailing instructions will be available at the skippers meeting

#### 5. THE COURSES

The courses to be sailed will be as follows:

Day 1 – 2 Shorter races will be attempted

Day 2 – 1 Distance race around fixed marks

#### 6. SCORING

Each class shall be scored using the low point system of Appendix A with no races excluded. This changes RRS A2.1.

1 race is required to be completed to constitute a series.

# 7. SAFETY

All boats shall comply with United States Coast Guard and State safety equipment regulations. It is the responsibility of each skipper to determine if they should start a race, continue racing, or if wearing a life jacket is appropriate. This does not supersede any class rules or regulations that may require wearing of life jackets while on the water.

# 8. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

# 9. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance.
