AMMENDMENT #1 - 8.3.2020

Statement of OA Intentions for 2020 ILCA- Great Lakes Regatta. The regatta is currently planned to proceed as scheduled on September 12th and 13th, 2020. The Organizing Authority, Rochester Yacht Club, intends to follow all New York State laws and CDC guidelines during the event. In the event the laws, rules or recommendations change these COVID-19 guidelines may be altered at any time before or during the event. The OA is committed to provide a competitive and safe racing venue for all competitors, staff, and volunteers. The following Covid-19 guidelines include:

General

- 1) Registration fees will be 100% refunded up till the day of event for competitors that have last minute changes or cannot compete in the event as planned.
- 2) Regatta registration will be capped at 75 registered competitors to avoid congestion on the grounds and in the facilities.
- 3) At time of arriving to club competitors will be assigned to a launch site, please contact the Race Chairman at time of arrival or proceed directly to the registration booth for your assignment. A maximum of 25 boats will be stationed at each launch site.
- 4) Competitors will be required to station their boats on land 8' apart from other boats in all directions.
- 5) Competitors and coaches will be required to wear face coverings while on land and not social distancing (buffs are acceptable).
- 6) Competitors and coaches will not be permitted inside the main club house during the event. The burgee bar, Junior sailing center, and locker rooms will be accessible to competitors and coaches during the entire event.

Camping and Housing

- 1) Competitors No housing will be provided.
- 2) Camping will be permitted on RYC property. All camping rules set forth by the OA must be adhered to. Failure to follow camping rules will be grounds for disqualification from the event.
- 3) To camp on site, you will be required to notify the OA at time of registration and receive a tag for your tent that must always be visible.

Travel from Outside New York State

- 2) All competitors that travel from a state on the NY state quarantine list must provide documentation of quarantine prior to the event.
