

NOTICE OF RACE Poinsettia Regatta Saturday December 14, 2019 Oceanside Yacht Club



1 RULES

- **1.1** The regatta will be governed by rules as defined in The Racing Rules of Sailing.
- 1.2 No national prescriptions will apply.
- 1.3 Changes to racing rule(s), if any, will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.

2 ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all boats of the RS Tera (rigged with a sport sized mainsail) and Sabot classes. The Race Committee may assign junior and senior fleets within these classes depending upon the number of registrants. All junior participants must wear a PFD. On a first-come-first-serve basis, OYC members may use an OYC Sabot or RS Tera. Advanced reservations are encouraged.
- 2.2 Registration: Eligible boats should register using www.RegattaNetwork.com (Event ID19935 2019 OYC Poinsettia Regatta) before 20:00 on December 13, 2019 and complete the Race Entry Card and Waiver, Attachment A, or the equivalent on Regatta Network.
- 2.3 Late entries will be accepted under the following conditions: a completed Race Entry Card and Waiver, Attachment A, and required fee are submitted to the Race Committee prior to the conclusion of the skippers' meeting. The Race Committee may extend this deadline if applicable to all participants.

3 FEES

3.1 Required fees are as follows:

Oceanside Yacht Club member \$20 Non-Oceanside Yacht Club member \$25

4 SCHEDULE

- **4.1** Date of racing: December 14, 2019
- **4.2** Number of races: Five races are planned for each class and fleet.
- **4.3** A skippers' meeting is scheduled for 10:00 on December 14, 2019 at OYC.
- 4.4 The scheduled time of the class flag (warning signal) for the first race is 11:57. The warning signal will be made three minutes before the starting signal. This changes RRS 26, Starting Races.
- **4.5** No warning signal will be made after 15:30.

5 SAILING INSTRUCTIONS

Sailing instructions will be available after 17:00 on December 9, 2019 at www.RegattaNetwork.com. Published sailing instructions include any supplementary sailing instructions that will be on the official notice board located at Oceanside Yacht Club office. As a courtesy, a first draft of Sailing Instructions will also be published at https://oceansideyc.net.

6 VENUE

- **6.1** Attachment B shows the location of parking and Oceanside Yacht Club.
- **6.2** Launching and parking:

Boats can be launched from public ramps in the South Harbor. Trailer parking near these ramps requires a nominal fee. Sail to end of I-Dock by OYC in North Harbor.

Alternatively, boats can be side-carried through a 4'-0" wide gate by the yacht club located in the North Harbor. Side dollies will be available. Trailer parking is permitted on North Harbor Drive near the yacht club.

6.3 Attachment C shows the protected outer harbor race area.

7 COURSE DIAGRAM

Attachment D show the course, the order in which marks are to be passed, and the side on which each mark is to be left. The race committee reserves the right to use additional courses not included in Attachment D. Course lengths will be set so that each race is about 25-35 minutes long.

8 PENALTY SYSTEM

For all classes, RRS 44.1, Taking a Penalty, is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

9 SCORING

- **9.1** The scoring system follows RRS Appendix A, Scoring.
- **9.2** Two completed races are required to constitute a series.
- **9.3** There will be no race discards.

10 PRIZES

Prizes will be given as follows:

Each fleet will award prizes for first through third place. Race results will be announced and prizes presented at Oceanside Yacht Club.

11 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

ASSUMPTION OF RISK; WAIVER, RELEASE AND INDEMNIFICATION: By entering this event, all racers agree to the following statement:


"I understand and agree that yacht racing involves the use and operation of marine equipment in extremely close proximity to other vessels, marks, buoys, and the shoreline in varied weather conditions and differing sea states, and further, that the captains and crews aboard other vessels may not be proficient in the operation of their respective vessels.

I further understand and agree that this event is organized by volunteers who are not maritime professionals and who may or may not have formal training in vessel operation or race organization, all of which involves a substantial element of risk, including the risk of property damage or of personal injury or death.

Notwithstanding these and other elements of risk and inconvenience, I wish to participate in this event because of my interest in yacht racing and the enjoyment and fulfillment that I derive from yacht racing.

Therefore, in consideration of the Race Organizers (as defined below) allowing me and my crew to compete in the event described in this Race Entry Card and/or Notice of Race (the "Event"), I, of and for myself and my Vessel, and my crew, my heirs, assigns, crew-members, partners, and agents (collectively "We"), hereby agree to accept any and all risks associated with this Event with the knowledge of the dangers and risks involved. We further agree to release Oceanside Yacht Club, including their respective owners, affiliates, officers, directors, members, employees, agents, committee persons, and race officials (collectively, the "Race Organizers"), and hold them harmless and indemnify them, from any and all disputes, actions, claims, demands, liabilities (collectively, "Incidents"), judgments, and attorney's fees which are related to or arise directly or indirectly from the activities associated with this Event (to the extent that We are involved in or participated in, or are alleged to have been involved in or participated in such Incidents), including, without limitation those due to the negligence, fault or other act or omission of the Organizing Authority." US Sailing Prescription Rule 82 shall not apply to this Event.
