1. RULES

The regatta will be governed by:

a. the rules as defined in The Racing Rules of Sailing ("R.R.S.") except as modified by this Notice of Race

b. the Safety Equipment Requirements for Inshore Races ("SER") as published by US Sailing and as modified by this Notice of Race

c. the Sailing Instructions of the Windermere Regatta

2. FEES

The Entry Fee is \$40, payable on the Regatta Network site.

3. SHORESIDE ACTIVITIES:

Skippers Meeting: Saturday, June 13, 9:00 AM, likely online Awards: Sunday, June 14, immediately following racing, location TBD, or online at a later date

4. SAILING INSTRUCTIONS

Sailing Instructions will be available online or at the yacht club prior to racing.

5. VENUE

Headquarters will be located at the Anacortes Yacht Club

6. COURSES

Race Courses will be in the vicinity of Fidalgo Bay. An effort will be made to run a medium distance race on Sunday, pending wind conditions and number of races completed on Saturday.

7. SCORING

Scoring shall be based on PHRF Time on Time or One Design with minimum of 5 boats per class.

*In the case of a Shorthanded Regatta, Divisions will include Singlehanded Flying Sails, Singlehanded Non-Flying Sails, Doublehanded Flying Sails, Doublehanded Non-Flying Sails, and Family/Household.

*In the case of a "Standard" Regatta, divisions will be created based on grouping similar rating bands and boat types.

8. RADIO COMMUNICATIONS

VHF radios will be required, monitoring Channel 72

9. PRIZES

Prizes shall be given to the first three places in each division.

10. DISCLAIMER OF LIABILITY

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See R.R.S. 4, Decision to Race. The Race Organizers and/or their respective members, officers, board of directors, staff or representatives) will not be responsible for damage to any boat or other property or the injury to any competitor, sustained as a result of participation in this event, regardless of the fact that such damage may be, in whole or in part, due to negligence. By participating in this event, each competitor agrees to release the Race Organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law, whether caused in whole or in part by negligence. Neither the adoption of Category 3 requirements, their use and modification by the Organizing Authority, nor the inspection of a boat in any way reduces the complete and unlimited responsibility of the skipper. It is the sole and exclusive responsibility of the skipper and crew of a boat to decide whether or not to start or continue in a sailing event.

* There will likely be a waiver for Covid-19 to promote the continuing health and safety of participants, and increase the ability to contact participants.

11. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$300,000 per event or the equivalent.

12. PHOTOGRAPHY

Each boat's skipper(s), owner(s), and crew extend to Anacortes Yacht Club the absolute right and permission for any photography and video footage taken of persons and/or boats during the event to be published in any media worldwide for any editorial, promotional, and/or advertising purpose or to be used in press information.
