#### 1 RULES

This race will be governed by the *rules* as defined in the *Racing Rules of Sailing*.

*In light of the ongoing COVID-19 pandemic, racers are strongly encouraged to follow state and local guidelines for social distancing and group size in effect at the time of the race (eg, currently 6ft between non-household members as well as mask, buff, or bandana over the nose and mouth when closer than 6ft; group size of 5 or fewer non-household members).*

#### 2 CLASSES

Spinnaker class is open to all boats with current PHRF ratings; non-spinnaker class is open to any boat at least 22ft LOA. If a boat does not have a current PHRF rating, the Race Committee (RC) may assign a rating for purposes of this race only. Area A Random Leg Course (RLC) handicap ratings will be used for scoring.

#### 3 RACE ENTRY & FEES

Race entry will be online only (<https://www.regattanetwork.com/event/20851>), and payment of entry fees is required in advance. Entry fees are \$30 for US Sailing Association members and \$35 for non-members of USSA.

The Wild Bill Rig Race Perpetual Trophy will be engraved with the winners' names and classes and displayed at Channel Islands Yacht Club. *Details regarding the possibility of a post-race meal and awards presentation will be available at a later date.*
