NOTICE OF RACE v1 6/29/2020

1 RULES

1.1 The regatta will be governed by the rules as defined in Racing Rules of Sailing.

1.2 Racing Rules of Sailing Part 4 preamble will be changed as follows: When flag Y is displayed ashore, RRS 40 applies at all times while afloat. Racing rule A4.1 will be changed as follows: A boat starting later than four (4) minutes after her starting signal will be scored DNS . Racing rule 28.1 will be changed as follows: Except at a gate, boats shall pass between the race committee boat signaling the change of course and the nearby mark. Racing rule 33 will be changed as follows: During the race, “gate” marks may be repositioned without signal for minor changes in course. Racing rule 33 (a) (2) will be changed as follows: The race committee will display a green rectangular board if the direction is changed to starboard or a red rectangular board if the direction is changed to port. Racing rules 35 and A4.1 will be changed as follows: Boats failing to finish within thirty (15) minutes after the first boat sails the course and finishes will be scored DNF. Sailing instructions may be modified verbally on the water

2 ADVERTISING

2.1 Advertising will be restricted to Category A as stated in ISAF Regulation 20.

3 ELIGIBILITY AND ENTRY

3.1 Recognized classes will be **Sunfish**.

3.2 All entrants must comply with RRS 75.1

4 FEES

4.1 Entire Series: \$25.00.



5 QUALIFICATION

5.1 To be scored for series awards a boat must register for the entire series.

7 SAILING INSTRUCTIONS

The sailing instructions will be available no later 7/3/2020

8 RACING AREA

Manasquan River between Route 35 Bridge and Point Pleasant Canal.

9 THE COURSES

Windward/Leeward/Triangular/Around the Buoys courses.

10 SCORING

10.1 The Low Point scoring system of RRS Appendix A will apply. RRS A.9, Race Scores in a Series Longer than a Regatta, replaces RRS A4.2.

10.2 The number of scheduled races is “multiple”, of which 1 must be completed to constitute the series.

10.3 A registered boat that does not come to the starting line will be scored DNC. DNC’S are excludable as provided below.

10.4 No race shall be declared official unless three or more entrants come to the starting line.

11 BERTHING

Boat Storage is available free of charge, to those intending at least 50% of the races. Skippers intending to store their boat at MRYC during the series should notify MRYC’s dockmaster at 732-528-6792 in advance of arriving.

12 RADIO COMMUNICATIONS

A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

13 REQUIRED SAFETY EQUIPMENT

Notes: 1. All boats must carry a towline solely dedicated to towing and/or anchoring and readily available for use at all times. Line must be at least 24’ long and of sufficient



strength to tow a swamped boat.

14.2 The minimum number of awards for each class will be according to the number of contestants in each class as follows:

16 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of the policy limit of their homeowner’s insurance policy per event or the equivalent thereof.
