**RULES**: This race will be governed by the Rules as defined in the *Racing Rules of Sailing 2017-20*. In light of the ongoing COVID-19 pandemic, racers are strongly encouraged to follow state and local guidelines for social distancing in effect at the time of the race (eg, currently 6ft between non-household members as well as mask, buff, or bandana over the nose and mouth when closer than 6ft).

**SAILING INSTRUCTIONS** This will be a Pursuit Race, ie, the boat with the highest handicap rating (theoretically, the slowest boat) starts first and subsequent boats start in order of their decreasing ratings. The start times will be calculated during the Skippers Meeting based on the participants' ratings and the length of the assigned courses. The order in which the boats finish determines their places within each fleet. The start and finish line will be at the south entrance to Channel Islands Harbor (between markers #1 and #2). **CLASSES:** Spinnaker & non-spinnaker classes are open to any boat at least 20ft LOA. If a boat does not have a current PHRF rating, the Race Committee (RC) may assign a rating for this race only. Class breaks, course assignments, and start times will be established during the Virtual Skippers Meeting.

**RACE ENTRY & FEES**: Race entry and payment of fees is available online only. Entry fees are \$35 for for non-members of US Sailing Association; USSA members' fees are discounted by \$5.
