SAILING INSTRUCTIONS

Organizing Authority: Richmond Yacht Club, Point Richmond, California

1 RULES and more rules...

This regatta will be sailed in compliance with current Contra Costa County Covid-19 Health Order. This Order requires that all individuals in Contra Costa County, over the age of 2 years, wear face coverings in accordance with guidance issued by the State of California. Richmond Yacht Club requires all individuals to wear face coverings at all times when on the docks or grounds of Richmond Yacht Club, and requires participants to maintain a 6 foot distance when not on your boat. Violation of these requirements observed by the Race Committee, or a competitor, may result in a protest by the Race Committee for an individual race, or the regatta.

- **1.1** This regatta will be governed by the rules as defined in the Racing Rules of sailing (RRS), and the Moore 24 class rules. **1.3 Appendix V1. Will be in effect.**
- **1.2** RRS 40.1 will be deleted and replaced with: "Competitors shall wear personal flotation devices while on race course, except briefly while changing clothing or personal equipment."

2 NOTICES TO COMPETITORS

Notices to competitors will be posted on-line, via the Regatta Network notice board, all notices will be posted by 2000 (8 pm) the day before.

Competitors meeting well be held at 1900 on August 20th via ZOOM.

3 CHANGES TO SAILING INSTRUCTIONS AND PENALTIES

3.1 Any change to the sailing instructions will be posted before 0945 on the day it will take effect, except that any change to the schedule of races will be posted by 1900 on the day before it will take effect.

PENALTIES AT THE TIME OF AN INCIDENT

The Moore 24 class will require a two-turn penalty for an incident within the zone and a one-turn penalty for an incident outside the zone. This changes RSS 44.1

4 No SIGNALS MADE ASHORE

None... all on the water..

5 SCHEDULE OF RACES

- Day 1....8/21/2020 first warning by sound and VHF 1155
- Day 2....8/22/2020 first warning by sound and VHF 1155
- Day 3.... 8/23/2020 first warning by sound and VHF 1055
- **5.2** After the first race each day, the warning signal for each succeeding race will be made as soon as practicable. To alert boats that another race will begin soon, a series of short sound signals and a radio announcement may be made on VHF channel 69.
- 6 The Class President will be the fleet spokesperson for on the water communications with the Race Committee...

7 RACING AREAS

There are 2 Racing Areas. The long distance race will start in OC area and will be using fixed and inflatable marks in the main bay. Pelican will be start and finish boat for the Friday races.

Olympic Circle area

Pelican will be start and finish boat using all inflatable marks for the buoy races.

VHF 69 will be the race committee working channel

8 THE COURSES

- **8.1 Attachments A and B** shows the courses, the order in which marks are to be passed, and the side on which each mark is to be left.
- **8.3 There will not** be an Offset Mark set at any of the weather marks that are fixed government or YRA marks. There may be an Offset Mark "O" set 5-15 boat-lengths from the weather mark on the buoy races. The offset mark is to be passed in sequence as designated in the course descriptions on **Attachment B**.
- **8.4** The course to be sailed will be designated by flag displayed from the Race Committee signal boat, and announced via VHF.

9 MARKS

- 9.1 Marks will be yellow inflatable cylinders or tetrahedrons; offset mark will be an orange ball.
- **9.2** Replaced marks, as provided in instruction 12, will be a different color .

10 AREAS THAT ARE RESTRICTED

The extension between Alcatraz Island and Bell Buoy 7 is restricted. The extension between Angel Island and Blunt Buoy G3 is restricted. I beam and Anita Rock buoy near St. Francis YC shall be passed on the bay side.

11 THE START

11.1 Races will be started by using sounds and the VHF due to the limited r/c crew.

- **11.2** The starting line will be between a staff displaying an orange flag on the Race Committee signal boat and the course side of an inflatable mark.
- **11.3** A boat starting later than 5 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A4 and A5.
- **12 CHANGE OF THE NEXT LEG OF THE COURSE** To change the next leg of the course, the Race Committee will lay a new mark (or move the finishing line) and remove the original mark as soon as practical.

13 THE FINISH

The finishing line will be between a staff displaying an orange flag on a Race Committee boat and an inflatable mark..

14 TIME LIMITS

14.1 The time limit for distance race shall be 4 hours.

The time limit for each buoy races shall be 90 minutes.

14.2 Boats failing to finish distance race within 45 minutes after the first boat in the fleet sails the course and finishes will be scored Did Not Finish without a hearing. This changes RRS 35, A4 and A5.

Friday, Saturday and Sunday boats failing to finish buoy races within 25 minutes after the first boat in the fleet sails the course and finishes will be scored Did Not Finish without a hearing. This changes RRS 35, A4 and A5.

15 SCORING

15.1 Seven races are scheduled. Five races shall constitute a series. One (1) discard after the completion of five races. This changes the RRS A2.1.

16 THE COURSE's

17 PROTESTS AND REQUESTS FOR REDRESS (will be challenging)

- **17.1** Protest forms will be available on line. Protests shall be delivered to a Race Committee representative in the Race Office within the protest time limit, which shall be 60 minutes after the committee boat returns to the dock, time will be announced on the VHF. The return time will be posted on the official on line notice board. Would help the protest process a lot if boats intending to file a protest would inform the race committee before leaving the race area.
- **17.2** Notices will be posted within 30 minutes of the protest time limit to inform competitors of hearings in which they are parties, and we will announce hearing times via VHF

17.3 Notices of protests by the Race Committee or protest committee will be posted on line to inform boats under RRS 61.1(b) and we will use the VHF to announce any protest hearings. The plan is to hold very socially distancing protest hearing in the middle of a parking lot or dirt lot .. location to be announced.

18 SAFETY REGULATIONS

18.1 Check-in: Boats are required to check in with the Race Committee by sailing by the committee boat, on starboard tack, prior to the first warning at least 15 minutes before the first start first race each day. **No radio check in is allowed.**

However channel 69 should be monitored at all times for information from the race committee.

- **18.2** Boats leaving the racing area prior to the conclusion of racing are requested to notify the Race Committee before leaving the course area VHF 69. If that is not possible, the competitor shall notify a shore side member of the Race Committee or a club staff member (Bartender, Harbormaster) immediately after arriving ashore.
- **18.3** A boat that retires from a race shall notify the Race Committee as soon as possible.

19 RADIO COMMUNICATIONS

- **19.1** A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats.
- **19.2** The Race Committee may use **VHF channel 69** (to communicate information about the day's racing and the sail numbers of boats that are OCS or have violated RRS 27. Neither failure of the Race Committee to communicate the sail numbers of recalled boats in a timely manner, nor failure of a recalled boat to receive or hear transmitted information, will not be grounds for redress. This changes RRS 62.1.

20 Trophies

Trophies will be awarded for 1st through 4th Place. Other trophies may be awarded as deemed appropriate., as soon as possible after completion of the event. Meeting place to be determined.

21 INTERFERENCE WITH COMMERCIAL VESSELS

Boats shall not impede the passage of ship traffic while racing. Rule 9 of the Inland Rules of the Road applies with respect to all shipping traffic on San Francisco Bay and its tributaries. A violation of Rule 9 is subject to protest by any competitor or by the Race Committee. Compliance with the RRS 60-63 will not be required with respect to a protest involving a Rule 9 infraction. A violation of Rule 9 may not be exonerated by a Turns or Scoring penalty. Any complaint received by the Race Committee from the United States Coast Guard or the captain or bar pilot of any ship that has sounded five blasts on its horn during the course of a race shall result in an automatic protest by the Race Committee if the captain, bar pilot or Coast Guard identifies an offending boat by sail number. In any case where a ship has sounded five blasts on its horn, a presumption shall be created at the protest hearing that the protested yacht(s) has (have) violated Rule 9 and the protested yacht(s) shall have the burden of proving that it(they) did not impede the progress of the ship. Race Committee chase boats patrolling the race course may hail boats to alter course to avoid impeding ship traffic. Failure of any boat to comply with the hail of the Race Committee shall result in an automatic protest by the Race Committee. A protest of a Rule 9 infraction by a competitor may be made at any time prior to the conclusion of the regatta, but not more than 24 hours after the incident. A protest by the Race Committee for an infraction of Rule 9 may be made at any time up to two days after the conclusion of the regatta. The Richmond Yacht Club will cooperate and provide relevant information to any investigations by the Coast Guard or other competent governmental authority of violations of Rule 9.

22 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

YRA mark location BOC (B bottom of circle) to port (RYC inflatable)

RYC Bob Klein buoy to Starboard (small yellow buoy just north of Southampton)

YRA mark location BOC (B bottom of circle) to starboard (RYC inflatable)

Restricted Areas

The following objects shall be left to shoreward:

Bell buoy 7 off the west end of Alcatraz

.Above obstruction is not a mark of the course. I beam and Anita Rock buoy near St. Francis YC shall be passed on the bay side passed on the bay side.

The extension between Angel Island and "Blunt buoy G3 will be considered an obstruction. .
