NOTICE OF FIASCO

Saturday August 8, 2020 at 1100 Hours

Lake Dillon, Colorado

You are cordially invited to participate in a Fiasco in memory of Past Commodore, Race Director, Star Fleet Champion, US Sailing National Judge and Life Member PAUL KRESGE. Dillon Yacht Club and Dillon Marina are the Organizing Authorities.

1. RULES

1.1 This event will be governed by the rules as defined in The Racing Rules of Sailing 2017-2020.

1.2 The Racing Rules will be changed as follows:

1.2.1 RRS Appendix A2: Scoring – See Section 8

1.3 **Participants shall make their best efforts to comply with current Summit County COVID guidelines.**

1.4 **THIS IS A SINGLE HANDED, OR DOUBLE HANDED RACE. NO MORE THAN TWO PERSONS MAY BE VISIBLE ON DECK AT THE START AND END OF THE RACE!**

2. ELIGIBILITY AND ENTRY

2.1 This event is open to all sailboats with slips or dry stored on Lake Dillon on the date and time of the event. Membership at the Dillon Yacht Club is NOT REQUIRED.

2.2 Those wishing to compete shall register electronically, sign an electronic waiver at <https://www.regattanetwork.com/event/21123> and fill out a daily COVID health form the day of the race at <https://dillonyachtclub.com/covid-19-health-form>

2.3 All boats competing must display the mainsail number identical to the number they registered with, or report to the RC a change in sail number PRIOR to the start of racing.

2.4 It is the owner's responsibility to carry liability and casualty insurance to cover all potential and actual claims and losses and to provide proof on request of the OA.



3. CLASSES

3.1 All boats shall be included as a single fleet

3.2 If a boat does not have a S.A.I.L. PHRF rating certificate, the Organizing Authority will assign a rating to that boat.

4. FEES

4.1 There are NO fees, however, please consider a donation in honor of Paul to the Dillon Junior Sailing Program when registering on Regatta Network.

5. SCHEDULE

5.1 A competitors meeting shall be held via VHF Radio on Channel 69 at 10:00 AM on the day of the race

5.2 The event shall have simultaneous starts in Frisco Bay near Frisco Marina and Dillon Bay near Dillon Marina, competitors shall finish at the marina where they begin.

5.3 The Scheduled warning time for the race will be 11:00 AM.

5.4 Only one race is scheduled for this event.

6. SAILING INSTRUCTIONS

6.1 Sailing Instructions will be the same used for the Dillon Marina Beer Can Series, this is a friendly, fun event. Be nice, stay on the boat, no protests, give all participants plenty of room.

6.2 This is a NO SPINNAKER event.

6.3 Each boat shall round each of the 12 marks shown on Attachment "A" in any direction and in any order. In addition, each boat shall round mark "PK" in Frisco Bay

6.4 When rounding a mark, a designated crewmember shall take a picture of the mark showing the mark number. Picture files shall be sent to dillonfiasco@gmail.com with a subject line of the boat's name and sail number no later than 6 PM the day of the event. Failure to do so for each mark will void the boats time.

6.5 There is a NO GO ZONE to the North and West of Sentinel Island as shown on Attachment "A". Boats entering the zone will be disqualified.



7. VENUE

7.1 The race will be held on Dillon Reservoir

8. SCORING

8.1 PHRF scoring will use the Sailing Association of Intermountain Lakes PHRF time on time correction using the formula:

$$\text{Corrected time} = 715 / (515 + \text{PHRF Handicap}) \times \text{Elapsed time}$$

9. PRIZES

9.1 There will be a single prize of a bottle of Gosling's Black Seal Rum, the winner must be over the age of 21 to claim the prize.

10. COMMUNICATIONS / SAFETY

10.1 RC will monitor VHF channel 69 for all communications. All boats must have a properly functioning VHF radio on board

10.2 RC, at it's discretion, may inspect any boat to insure it has required USCG safety equipment on board. Each crewmember shall be familiar with the proper use of the safety equipment and radio.

10.3 In the event of an emergency, call 911.

11. DISCLAIMER OF LIABILITY

11.1 Competitors participate in this race entirely at their own risk. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during or after this race. See RRS 4 "Decision to Race".

Before the race, each skipper and their crew must sign the electronic Waiver of Liability which will include an acknowledgement of the COVID protocols.
