#### 1. Rules

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2. RRS 40 will be changed to require competitors wear a personal flotation device while racing.

#### 2. Eligibility and Entry

- 2.1. This is an Invitational regatta for boats winning a club series or regatta in the 2009 season.
- 2.2. A list of invited yachts is attached.
- 2.3. Eligible boats may register at [Regatta Network](#) or by filling out the Entry Form and presenting it to the Santa Cruz Yacht Club before 1055 March 14, 2010

#### 3. Fees

- 3.1. There are no entry fees for this invitational regatta

#### 4. Schedule

- 4.1. Registration will be March 14, 2010 between 1000 and 1100
- 4.2. There will be a competitors briefing March 14, 2010 at 1100
- 4.3. There is one race scheduled for March 14, 2010. There is one make-up day March 21, 2010.
- 4.4. The scheduled time of the warning signal each day is 1255

#### 5. Sailing Instructions

- 5.1. The Sailing Instructions, including courses to be sailed, will be available after 1100 on March 14, 2010 at the competitors briefing

#### 6. Venue

- 6.1. Racing will be around buoy enclosed courses, between Capitola and Natural Bridges.

#### 7. Prizes

- 7.1. The overall winner on corrected time will be designated as the 2009 Cliff McNamara Champion of Champions and will have the boat name affixed to the perpetual trophy.

#### 8. Disclaimer of Liability
