Dear 2012 U.S. Junior Championship Competitors,

On behalf of the Organizing Committee and US Sailing, we are thrilled to welcome you to The San Francisco, St. Francis and Tiburon Yacht Clubs. The Organizing Committee has been planning for this event for some time, and we hope you have a great sailing experience and that your stay in Marin County will be a memorable one. There are recreational events planned during the regatta, in addition to racing, and we are looking forward to your arrival in August.

REGISTRATION:

Registration will be open on Monday, August 6th from 2:00pm to 4:00pm. Upon arrival at the SFYC (singlehanded and doublehanded) or TYC (triple/quadruplehanded), depending upon fleet, proceed directly to registration. The registration team will review that all forms have been correctly submitted and you will be issued a nametag. Your nametag will be used as your Meal Ticket and for entry into the events during the week. Sears (triple/quadruplehanded) competitors will have weigh in. Your life jacket will also be inspected at registration. Please refer to the NOR for requirements. Finally, once you have registered, you will be given your housing assignment.

Competitors will be expected to install the provided hull stickers and sail numbers following registration.

AIRPORT INFORMATION:

Ground Transportation for arriving competitors will be coordinated <u>only</u> between San Francisco International (SFO) and SFYC or TYC, depending upon fleet. *You will need to make your way to the baggage claim area without an escort. Please advise your parents to make appropriate arrangements with the airlines if you will be an unaccompanied minor and contact the Transportation Chair Dianna Blodgett (415) 272-1974.*

Don't forget to include SFYC's name and address on your luggage tag in the event your bags are delayed: SFYC, 98 Beach Road, Belvedere, CA 94920, (415) 435-9133.

SFYC greeters will be in the baggage claim area of the applicable airport with a "SFYC" sign and will provide transportation to The San Francisco or Tiburon Yacht Club, depending upon fleet. The airporter will be \$20 each way and should be booked at the time of registration.



ARRIVAL and DEPARTURE TIMES:

Early arrivals are not permitted – no exceptions. Being "Invited" by a SFYC, TYC or St.FYC member is *not* an exception to this rule. Violations will be dealt with strictly by the Organizing Committee and may be passed to the Protest Committee.

Arrival, for all competitors flying, should be scheduled for Monday, August 6th **before** 1:00pm. No early arrivals will be permitted. Departure for all competitors will be on Friday, August 10th unless other arrangements are made and approved. Requests for early or late departures must be made with US Sailing's Liz Walker at lizwalker@ussailing.org at least two weeks in advance. DO NOT make flight arrangements outside these windows until your request has been approved.

Competitors may depart the event after the Awards Ceremony by car, with a parent or guardian or on the bus. Please indicate when you register how you will be departing. If you are driving, please be sure to complete the attached form and return it with your registration materials. No person will be allowed to leave the premises without the proper information on file.

Airline Arrival:

Competitors should schedule their flights to arrive at San Francisco International Airport (SFO) after 8:00am and before 1:00pm on Monday, August 6th. If your flights arrive outside of these times, special arrangements will need to be made at your own expense. Permission from US Sailing (above) must be granted. United Airlines has provided a discount code that can be used for travel to and from the Junior Championships. Please use code ZMEHE280636 for discount. Visit http://membership.ussailing.org/sailors/united.htm for more information.

When entering your flight details, be sure to let us know if you are making a connection. That way we will know if you are delayed. For example, please write it as United 123/789; arriving at 1:00pm.

FOR YOUR OWN SAFETY, DO NOT ACCEPT RIDES OR TRANSPORTATION to or from San Francisco International Airport (SFO) that have not been arranged through SFYC.

Airline Departure:

Competitors should NOT make reservations for a departing flight earlier than 8:30pm on Friday, August 10th so you have time to get to the airport. No event housing will be provided to competitors for Friday night or later.

Transportation will be provided for competitors from SFYC at 6:00pm Friday, August 10th. The airporter will be \$20 each way and should be booked at the time of registration.

If you are traveling as an unaccompanied minor or are 15 or under, please be sure to bring funding to pay the separate unaccompanied minor fee at check in for your return flight (cash or travel checks). We have knowledge of instances where sailors have flown out on their own, but not been allowed by the airline to fly back on their own. We would rather you be over prepared rather than under prepared.

TRAVEL DELAYS OR QUESTIONS:

Any questions regarding transportation should be directed to *Dianna Blodgett*, maisonmac@comcast.net. *It is imperative that you enter in your arrival and departure information as part of your registration*. Your registration must be complete no later than July 26. *Please note in your e-mail whether or not you will be traveling as an unaccompanied minor so we can send you the information you will need to provide the*



airline. You may use the link you received from Regatta Network to update your plans at any point until the deadline.

If your plans change after the deadline, please e-mail the registrar, Angie Lackey Olson at lackeyad@comcast.net. We will be tracking the arrival of each person carefully. *Changes in your travel schedule can be made prior to arrival but we ask that we receive all changes not later than* August 1. *Please be sure to go into your registration and update the information there as well.*

If there is a flight delay or problems with your itinerary, please call Dianna Blodgett at (415) 272-1974. If there are additional problems, other emergency numbers are Michelle Farabaugh, (408) 497-2551 or Alison Russell at (408) 888-3190.

DRIVING INSTRUCTIONS:

Local competitors can drive to SFYC or TYC, depending upon fleet. Please submit a driver's release. Cars will be left at SFYC or TYC for the duration of the Junior Championships. Car keys will be held by SFYC and returned upon conclusion of the Awards Ceremony on Friday. There will be no driving of personal cars during the regatta. Offenders will be dealt with strictly.

MEDICAL FORM:

Each competitor must send a completed Medical Form along with all of the required waivers to Angie Lackey Olson at the address on the bottom of the form by July 26. If any medical issues change after that date, it is the responsibility of the parent/competitor to notify the regatta Registrar. It is suggested that you bring a copy of your insurance card with you.

HOUSING:

US Sailing Regulation 10.01 will be in effect from the moment you arrive at the venue until you are home or at the airport. Offenders will be dealt with strictly as stated in the Notice of Race.

<u>All</u> competitors will be assigned to a host family at registration. Housing assignments are fluid until the last minute so please do not contact the regatta chair or registrar to find out who you will be staying with. When you arrive at your host family's home, phone your parents with the host family and event co-chairs phone numbers.

Transportation to and from the Yacht Club will be by walking or by the host family if not within walking distance. You are required to attend all events.

BEING A GOOD GUEST IN YOUR ASSIGNED HOUSING:

Housing will be generously provided by local families in their homes. Please be as easy an houseguest as you can and show them that you appreciate their giving you a place to stay by not taking it for granted. When you arrive, call your parents with your host's name and phone number, and give your parents' names and number(s) to your host. Also, tell your host what your schedule is going to be so they know where you are at all times. Work out with your host where to hang your wet clothes, how "raid-able" their refrigerator is, etc. It's easy.....just be considerate! It is a nice gesture to bring a small present to your host or hostess to thank them for their hospitality.



MEALS:

Meals for each competitor will be provided throughout the regatta. A Continental Breakfast will be served at the club each day. Lunches will be made in the morning by the competitors and distributed on the water by coach and support boats. Dinners will be served at either TYC, Bay Model or StFYC on each night and with the host family on Wednesday night. The awards ceremony will be Friday evening at SFYC upon the completion of boat pack up.

GUEST MEALS:

A SFYC guest card can be requested in advance as part of your registration. SFYC dining room will be open for dinner Wednesday through Friday. Lunch is served Thursday and Friday. A guest card is required and payment is by cash or check only. Registration for the Spectator Boat with lunch as well as the Awards Dinner on Friday, August 10th is strongly recommended to be done with your registration. Late requests may not be able to be accommodated due to space limitations.

PACK UP

Failure to assist in the pack-up will result in forfeiture of \$250 of the damage deposit and may result in a competitor not receiving a charter at a future US Sailing event.

AWARDS CEREMONY

The awards ceremony is on Friday August 10th. *Attendance by competitors is mandatory and is included in your entry fee.* Parents may attend; but we would ask that you sign-up as part of registration. Tickets are \$25 per person. Last minute requests may not be able to be accommodated. Competitors will not be allowed to leave before the Awards Ceremony without prior approval of the National Chair and will only be granted for extenuating circumstances. Under no circumstances will competitors be allowed to depart prior to the completion of the boat pack up.

CHARTER BOAT ASSIGNMENT:

Charter fees will be paid online by the stated deadline of July 26th. **Damage deposits forms must be returned with your paperwork.** All boats will be provided fully equipped and no changes to the rigging, sheeting, blocks, or sails will be permitted. Doublehanded teams should bring their own bridles, and harness.

Representatives from Zim Sailing will be on site. You will be expected to help prepare and rig your boats each day and install the provided hull and sail numbers following registration.

On Friday, August 10th you will be expected to assist in the de-rigging and final check-in of charter boats. Failure to assist in the pack up can mean the denial of a charter at a future US Sailing event and a charge to



your damage deposit. All competitors will be assisting in loading the charter boats for transport. Sailors will not be released until all the boats have been checked in and loaded before attending the Awards Dinner.

CREW CHANGES:

Occasionally unanticipated situations may make it necessary for teams to change crew. Crew changes will be granted *only if* there is a valid reason (see the championship conditions for specifics). Sailors that wish to change sailing partners must submit a request in writing stating the reason. Requests should be e-mailed to Liz Walker at US Sailing at <u>lizwalker@ussailing.org</u>. Your alternate should have been provided to your Area Representative at the time of qualification.

We encourage you to plan well in advance in an effort to retain your original team unless a true emergency arises.

RACING CLINIC:

An Off-the-water Clinic will be held at SFYC or TYC, depending upon fleet, on Monday, August 6^{th} from 4:00pm – 6:00pm. This clinic will cover weather conditions, sailing area and rigging of the boats.

An On-the-water Clinic will be help at SFYC or TYC, depending upon fleet, on Tuesday, August 7^{th} from 10:00am – 6:30pm. This clinic will cover boat-handling, starts and practice races.

Participation in the clinics is mandatory. Permission to miss the clinic must be requested via lizwalker@ussailing.org in writing and in advance and will only be granted for extenuating circumstances.

PRIVATE COACHES ARE NOT PERMITTED

SPECTATOR BOATS:

It is our intent to provide spectator boats for those wishing to go on the water on Friday, August 10th. Spectators will be asked to sign up in advance as part of registration if they want to go on the water. Lunch is included. Tickets will be \$20 per person. Last minute requests may not be able to be accommodated so we recommend signing up in advance.

No alcohol will be allowed on the spectator boats. Please bring your own personal flotation device. ONLY FLAGGED SPECTATOR BOATS WILL BE PERMITTED IN THE RACING AREA. No private support boats are permitted. Please review US Sailing's Spectator and Coach Boat policy. Please refer to NOR 1.2.4. Please bring your own US Coast Guard Approved personal flotation device.

SAILING INSTRUCTIONS:

Sailing Instructions will be distributed at registration and will be available on the championship's website http://championships.ussailing.org/Youth/ChubbJrChampionships.htm

GEAR:

In August, the San Francisco Bay will be 55 degrees Fahrenheit and the breeze is consistently 15-25 knots daily. A fog layer is common during the summer months making the air temperature colder than expected, dropping 20 degrees at times. The current can be up to five knots between the yacht club and the race area. You will need to bring a wetsuit as well as appropriate foul weather gear. You will want to bring coats or fleece for the evening activities. Once the sun goes down, the air temperature will drop considerably. Several outdoor evening activities are planned.



WEATHER:

Real time weather information will be provided each race day on the official regatta bulletin board.

ALCOHOL AND DRUGS:

Per US Sailing Regulation 10.10.01: The use of alcohol or any illegal drug by a competitor will not be allowed or tolerated during the event. Offenders will be dealt with strictly as stated in the Notice of Race.

CURFEW:

There will be a 9:30pm curfew during the event; meaning that ALL competitors must be "home" where they are being housed by 9:30pm each night. These regulations are in effect from Monday, August 6th through Friday, August 10th. There will be no exceptions. We are not trying to make the event less fun; we are very concerned for your safety.

TREATING THE HOST CLUB PROPERLY:

The SFYC, TYC and St.FYC have been planning and working on this event for twelve months. You can be assured that they have planned the best possible event for you, from the racing, to the meals, the social events, and the housing. They take their regatta hosting very seriously, and as their guests you have an obligation to show that you appreciate their work. Please be as self-sufficient as possible and help others as needed. We expect that you'll jump in and help without being asked!

PERSONAL GEAR:

Mark your belongings in advance! We continually find clothes and equipment that competitors leave around throughout the event. All items with a name clearly on them usually get returned. Take a few minutes with an indelible marker and put your name on everything you will be bringing. Also, clearly paint or otherwise mark your personal equipment.

WE SUGGEST THAT YOU BRING THE FOLLOWING:

- Personal Flotation Device (life Jacket) & harness-Type III or V USCG approved only. (Mandatory)
- Sunscreen, sunglasses and hat
- 30-foot Tow Line (required for all boats)
- A water bottle- clearly labeled
- Notebook, pen, Rulebook
- Personal entertainment (e.g. books, Frisbee, iPod)
- A small burgee from your yacht club or sailing association (one per boat) to trade
- Appropriate attire for the awards dinner collared shirts, dresses or nice slacks
- Appropriate sailing gear and clothing for a range of weather conditions
- A thank you note or small house present for your host family

We welcome you to the SFYC, TYC and St.FYC and look forward to great racing, great food, and a great time at our club.

LIABILITY RELEASE AND ASSUMPTION OF RISK AGREEMENT

One must be on file for *each* participant: helm or crew

In consideration of the acceptance of my entry in this regatta, I (or my parent or guardian if under 18) hereby agree as follows:

- 1. **Risks:** I understand and agree that sailing and yacht racing involve risks of injury, death and property damage from a variety of situations and causes that can change at any time without notice, including but not limited to water, wind and weather conditions, tides, currents, waves, immersion and drowning, hypothermia, equipment failure, interactions with other competitors and/or of vessels not involved in the regatta, as well as with aquatic life, rocks, docks, pilings and buoys and other potential hazards. I have freely and knowingly chosen to participate in this regatta despite these risks.
- 2. **Racing Rules:** I have read and familiarized myself with the Racing Rules of Sailing, as modified by the Notice of Race and Sailing Instructions ("Racing Rules"), and I agree to be bound by them and by any decision of the Protest Committee.
- 3. **Decision to Race:** I understand and agree that the responsibility for a boat's decision to participate in a race or to continue racing is hers alone, and at the sole risk of the boat, her skipper and crew (see Racing Rule 4).
- 4. Release of Liability: To the fullest extent permitted by law, I agree to release US Sailing, The San Francisco Yacht Club, St. Francis Yacht Club, Tiburon Yacht Club and all other organizing authorities, Chubb Insurance Group, Gill North America, Zim Sailing, Switlik Survival Products and other sponsors, ("Sponsors") host organizations, race committees, protest committees, judges, referees, arbitrators, officials, class associations and all other persons involved in organizing, operating, hosting, managing, promoting or sponsoring this regatta and related activities, and all of their officers, directors, agents, employees and members ("Released Parties"), from any and all legal liability or responsibility for personal injury, death or property damage arising from or related to this regatta and any related activities, and I waive any right I might otherwise have to sue the Released Parties for negligence and any other cause for which liability may be released under California law.
- 5. Assumption of Risk: To the fullest extent permitted by law, I agree to assume all risk of injury, death and property damage that may arise from participating in this event as respects the Released Parties.
- 6. Liability of Competitors for Damages: This liability release and assumption of risk agreement is not intended to release liabilities, assume risks or otherwise modify the obligations of competitors under the Racing Rules. The responsibility of a competitor for damages arising from any violation of the Racing Rules shall be based on fault as determined by the Racing Rules, and shall not be governed by the legal doctrine of "assumption of risk." Any decision of the Protest Committee as to fault shall be final and binding, but the Protest Committee will not adjudicate damages (see Racing Rule 68). This agreement is not intended to alter any agreements or obligations between vessel charterers and owners.
- 7. **Safety:** Skipper/owner warrants and represents that he/she has taken all reasonable steps to ensure that skipper, crew and boat are adequately prepared for all possible contingencies, including appropriate safety equipment and procedures as may be required by law, by the Racing Rules, class rules or that a prudent seaman would consider advisable.
- 8. **Photos and Publicity:** I hereby grant to US Sailing and its representatives and assigns an irrevocable and unrestricted right to use and publish race results and images of me and of my boat taken during or in connection with the event, and I agree that US Sailing owns all rights to them, and its sponsors and representatives may use them for any purpose and in any form, in perpetuity, and without compensation.
