6.0 Signals

Racers shall listen to channel vhf 69 for any important changes, notices.

7.0 Schedule of Race

Sunday Sept. 9 2012 first warning horn at 11:55am, Races 1 and 2 of 4

Sunday Sept. 16, 2012 first warning horn at 11:55am, Races 3 and 4 of 4

10.1 The Courses

The course will be longer than one mile if possible to windward

11.0 Marks

The original Windward and Leeward Marks will be Tetrahedrons.

If committee boat is damaged by a racer, then the sailboat shall pay for all damages. The R/C will have a trailing marker and shall be considered part of the boat.

12.0 The Start

The R/C will be using a electric air horn for all signals

13.1 Recalls

Individual recalls will be signaled using RRS 29.1 A horn will be used as the sound signal and Xray code flag for visual signal the R/C may attempt to hail the sail numbers of premature starters, via VHF radio Channel 69

13.5 Starting line OCS

If a yacht is OCS at the start they may elect to not restart and instead accept the following time penalty assessed by the R/C of Three (3) minutes. If two or more boats are more than three boat lengths OCS, the R/C may attempt to signal a general postponement and re-start, as appropriate.

17.5 Penalties/Protests

Protests are to be delivered to the Race Committee at Coronado Cays Yacht Club Clubhouse.

Notice of Protest information will be posted on Us Sailing Regatta website and a copy to be posted in the club hallway.

Time of protest hearing will be subject to discussions with the interested parties involved.

Hearings will be held at Coronado Cays Yacht Club.

19.1 Withdrawal

A yacht may request a withdrawal by phoning 619-540-9875 no later than 24 hours before the start of the first race.

20.0 Scoring

The low point scoring system, RRS Appendix A, as amended by these instructions will apply,

“For Regatta scoring, ties will be decided in accordance with RRS, Appendix A8, except as noted. All ties unresolved by the first sentence of RRS Appendix A8.1 will be decided in favor of that yacht with the lowest total corrected time for the race(s) in the regatta”
