NOTICE OF RACE

1 - RULES

1.1 - The Midwest Cressy Qualifier is an elimination event for the 2013 ISSA National High School Championship "Cressy Trophy". The regatta will be governed by the 2009-2012 Racing Rules of Sailing, the prescriptions of US Sailing, the rules of the Laser Class, The ISSA Procedural Rules (PR), The Notice of Race, and the Sailing Instructions. In the case of conflict, ISSA Procedural Rules will take precedence.

1.2 - The top two finishers in Laser Standard division and the top two finishers in the Laser Radial division will qualify for the 2013 ISSA High School Championship for the Cressy Trophy in their respective divisions.

2 - ADVERTISING - will be restricted to Category A.

3 - ELIGIBILITY and ENTRY

3.1 - The Regatta is open to sailors registered as members of eligible schools, who have paid in full 2012-2013 MISSA/ISSA dues prior to the start of the regatta. Competing sailors must appear on the school roster submitted to the MISSA President or his representative prior to the start of the regatta. There will be separate divisions for Laser Standard and Laser Radial classes.

3.2 - Eligible schools and sailors must enter by registering online at www.wayzatasailing.com.

3.3 - The entry deadline is Monday, September 17th, 2012, at 6pm CST. No entries will be accepted after this date and time.

3.4 - Each sailor is considered a Cressy "team". Each sailor is limited to one (1) entry application.

3.5 - A school may enter as many Cressy teams as it wishes.

4 - FEES

4.1 - The entry fee is \$65 per competitor. Fee includes light breakfast and full lunch on Saturday & Sunday. One coach from each school will get lunch. Additional meals can be purchased on September 22 at competitors check in.

5 - BOATS

5.1 - All competitors must provide their own boat and equipment.

5.2 - No additional equipment other than screwdrivers, pliers, tape, telltales, bailers, snack bars, and drinking water may be carried on the water during the regatta.

5.3 – The Laser Standard division and Laser Radial division must be sailed single-handed. This modifies the Laser Class rule 7(a).

5.4 - Membership in the Laser class association is not required.

6 – SCHEDULE

Saturday, September 22, 2012

0800 – Competitors check in. Rigging of boats.

0900- Competitors Meeting—MANDATORY

1000 - First warning. Races will continue through the day.

Sunday, September 23, 2011

0800– Competitors check in. Rigging of boats.

0930 - Warning signal for first race

1430 - No race will start after this time.

7- BOAT ARRIVAL AND DEPARTURE

7.1 – Sailors may drop their boats and equipment off at the Wayzata Community Sailing Center beginning on Thursday, September 20. For boats and equipment arriving before Saturday morning, please contact Cappy Capper prior to arrival at 952-476-5875.

Likewise, if boats need to be kept at the Wayzata Community Sailing Center beyond the evening of Sunday, September 23, please coordinate with Cappy Capper.
