

NOTICE OF RACE

2013 FALL SCORE/DOUBLE HANDED SERIES

1 Rules

- 1.1 The series will be governed by the rules as defined in the *Racing Rules of Sailing*.
- 1.2 The SCYC 2013 Minimum Equipment Requirements (MER) for Santa Cruz Nearshore races will apply to the double Handed and Jib & Main classes and Santa Cruz Coastal will apply to the A and B fleet classes. (SCYC 2013 MER may be found at scyc.org under the racing tab)
- 1.3 Rule 40 will be changed to require competitors wear a personal flotation device while racing.
- 1.4 Changes to the *rules* will appear in full in the Sailing Instructions.

2 Eligibility and Entry

- 2.1 This series is open to any boat holding a valid 2013 Monterey Bay PHRF certificate.
- 2.2 There will be the following divisions: A fleet (PHRF<88), B Fleet (PHRF>89), Double Handed, Jib & Main (PHRF<181) and Jib & Main (PHRF>182). Double-handed division shall have exactly two persons on board. PHRF divisions shall have a minimum of two persons on board.
- 2.3 Eligible boats may enter by completing the online entry form at Regatta Network or scyc.org. Only online entries will be accepted.

3 Fees

- 3.1 Regular entry fee is \$85 if received by 2000 hours August 24, 2013.
- 3.2 Late entry fee is \$100.00 if received after 2000 hours August 24, 2013.
- 3.3 Registration closes at 1100 hours October 27, 2013.
- 3.4 All entry fees are nonrefundable.

4 Schedules

- 4.1 A competitors' meeting will be at 1030 hours on August 25, 2013 at the SCYC clubhouse.
- 4.2 The scheduled time of the first warning signal is 1225 hours each race day.
- 4.3 Six races are scheduled in the series. Two races are scheduled each day.
- 4.4 There will be an awards ceremony at the SCYC clubhouse on October 27 following racing.

5 Sailing Instructions

5.1 The Sailing Instructions will be available at the competitors' meeting and may be posted online at scyc.org.

6 Venues

6.1 Racing will be around temporary inflatable buoys or fixed buoys in Monterey Bay. The racing area will be bounded by Moss Landing to the southeast, Davenport to the northwest and extending five miles off shore.

7 Scoring

- 7.1 Three races are required to be completed to constitute a series.
- 7.2 When five (5) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score. This changes rule A2.

8 Prizes

- 8.1 Prizes will be given at the discretion of the organizing authority.
- 8.2 Boats entered in divisions with three (3) or more entries in the series are eligible for the 2013 Cliff McNamara Invitational Champion of Champions Regatta.

9. Disclaimer of Liability

9.1 Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The SCYC will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.
