## Midwinter Series 2013 - 2014 NOTICE OF RACE & ENTRY FORM

### Race Dates:

**November 3 – December 1 – January 5 – February 2 – March 2**

The Sausalito Yacht Club invites Sailors to come out for the Sausalito Yacht Club's 2013-2014 Midwinter Series. Races are held on the first Sunday of the month from November through March.

The intended racing area is the Knox/Yellow Bluff area of SF Bay using temporary and fixed mark courses.

The first warning signal for each race will be at 1200 hours.

Sailing Instructions will be posted on the club website and available at the club no later than Friday, November 2<sup>nd</sup>, 2013,

### RULES

The Racing Rules of Sailing shall govern this series, designated advertising Category A.

The low point scoring system RRS A4 shall be used. "Time on time" scoring will be used for PHRF divisions. A minimum of one race shall be completed to constitute a series. If four or more races are completed, one will be excluded. The series shall be scored as a series longer than a regatta.

### ELIGIBILITY

Entry is open to all yachts with a valid 2013 PHRF certificate and members of one-design fleets. A copy of your PHRF certificate must be received by the race committee or listed on the current YRA web site ([www.yra.org](http://www.yra.org)) to complete your registration. The Race Committee may deduct 6 seconds per mile for non-2013 certificate holders. Five or more one-design entries may constitute a class.

Sport Boat (displacement-to-length ratio of 112 or less **and** waterline length of 32 feet or less; i.e.,  $D / (2.24 \times (LWL / 10)^3) \leq 112$  and  $LWL \leq 32$  where D is displacement in pounds and LWL is waterline length in feet) and Multi-hull classes are also welcomed.

### ENTRY

Entry fee is \$100 for the entire series or \$30 for an individual race. Current members of US Sailing may deduct \$10 from their entry fee when registering online only.

Competitors may enter online (highly encouraged) by clicking on this link [REGISTRATION](#). Follow the instructions for payment and submission of your PHRF certificate.

SYC members may charge their entry fee on their club account.

### PRIZES

Results will be posted to the club's race notice board after each race and on the club website. Prizes will be awarded to winners of individual races after each race. Series trophies will be awarded after the last race of the series. Perpetual Trophies will be awarded at the annual SYC membership meeting.

Racers are invited back to the SYC Clubhouse for a complimentary bowl of after race soup and a video recap of the day's racing.

If entering by mail, complete the form on page 2 and return with a copy of your valid PHRF certificate and payment payable to "SYC Race".
