1. **Rules:** The regatta will be governed by rules as defined in *The Racing Rules of Sailing*.
2. **Advertising:** Advertising shall be in accordance with ISAF Regulation 20, Advertising Code.
3. **Eligibility and Entry:** Each competitor shall be a current year (2014) member of their respective country's Sunfish Class Association. USSCA membership forms will be available at registration. Eligible boats may enter by completing the attached form and sending it, together with the required fee, to BWYC. On-site registration will be allowed. On-line registration is with Regatta Network, [www.regattanetwork.com](http://www.regattanetwork.com).
4. **Measurement:** All boats must be measured against the class rules. A signed measurement form must be submitted to the registration desk for entry to be completed.
5. **Pan American Games Qualification:** This event will qualify the top 4 non-previously qualified nations to compete at the Pan American Games - Toronto 2015, in the Sunfish Class event. Qualification shall be subject to the requirements of the Qualification System as defined by the Pan American Sailing Federation (PASAF).
