## 1. RULES

The regatta will be governed by the rules as defined in the 2013-2016 Racing Rules of Sailing. SYC General Sailing Instructions will apply.

## 2. ELIGIBILITY

All entrants must be members in good standing of the PHRF Class and possess a valid rating certificate issued by the GYA-PHRF.

## 3. SCHEDULE OF RACES

Fall #5 & 6	Sunday-October 5, 2014	10:00
Fall #7 (SYC Closing*)	Sunday-October 19, 2014	14:00
Makeup (if needed)	Sunday-November 16, 2014	10:00

## 4. RACING DIVISIONS

Class A boats have a rating of 99 and faster (lower)

Class B boats have a rating of 102 and slower (higher)

## 5. SCORING & PRIZES

Yachts shall be scored in accordance with RRS Appendix A, based on corrected time. There will be two throw out only if all seven races are completed. Scores of DNS, DNC, OCS, DNF or DSQ shall be the number of boats that came to the starting area plus one.

Daily prizes for Races 1-6 will be awarded to the winner in each Division. Skipper or crew of the winning yacht must be present at the post race gathering to receive the prize. In the event the

Division winner is not present the prize will be awarded to the highest scoring skipper or crew in that Division present at the post race gathering.

## 6. Penalty System

US Sailing prescriptions in Appendix T Section A, rule T1 Applies: The first two sentences of rule 44.1 are changed to: "A boat may take a One-Turn Penalty when she may have broken a rule of Part 2 or rule 31 while racing. However, when she may have broken a rule of Part 2 while in the zone around a mark other than a starting mark, her penalty shall be a Two-Turns Penalty."

US Sailing prescriptions in Appendix T Section B, "Penalties Taken After a Race" apply.
