NOTICE OF REGATTA

1. RULES:

The regatta will be governed by the 2013-2016 Racing Rules of Sailing, the current rules of the J-24 Class Association, this Notice of Race, and the Sailing Instructions. This regatta is classified ISAF advertising code Category C, Appendix 1.

2. ELIGIBILITY:

2.1 The regatta is open to all J/24 sailboats as defined by the IJCA. Competitors must meet all ownership and class membership requirements and must complete all aspects of the registration process to become official participants. Registrants are required to present a valid J/24 Class Measurement Certificate at check-in in order to become official participants.

2.2 This is an advance registration event. Please register at Regattanetwork.com by **November 14, 2014**. Entry fee is \$275.00 prior to the deadline, or \$300.00 thereafter.

4. MEASUREMENT:

On site measurement will not be available at the regatta. If you do not have a current certificate you must make arrangements to be measured through the J/24 Class Association.

5. INSPECTION:

All official participants are subject to inspection and measurement at any time during the regatta for *rules* compliance including a fully completed and compliant Part D Class Measurement and Part C Inventory of Required & Optional Equipment forms.

6. FEES:

Boats will be charged \$275 if registered on or before November 14, 2013. After November 14 the entry fee will increase to \$300.00. Registration includes five (5) wristbands for dinner Friday and Saturday nights including complimentary beer. Additional wristbands can be purchased at check-in for \$45.00

7. SAILING INSTRUCTIONS:

The Sailing Instructions will be available at check in.

8. COURSE:

The course will be windward/leeward as described in the sailing instructions.

9. SCORING:

9.1 The Low Point System will be used as defined in RRS Appendix A and as modified herein.

9.2 Eight (8) races are scheduled. One completed race will constitute a regatta.

9.3 When five or fewer races have been completed, a boat's series score will be the total of her race scores. When six or more races have been sailed, a boat's series score will be the total of her race scores excluding her worst score.

10. PENALTY SYSTEM:

The Scoring Penalty (RRS 44.3) shall apply.

11. PRIZES:

11.1 Prizes will be awarded to the top five finishers.
