1 ORGANIZING AUTHORITY

The Organizing Authority (OA) is Texas Corinthian Yacht Club (TCYC).

2 VENUE

- 2.1 The event will be held at TCYC, 104 Park Ave, Kemah, TX 77565.
- 2.2 The racing venue will be on Galveston Bay, due east from the TCYC pier, approximately half a mile off shore.

3 RULES

- 2.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 2.2 RRS Appendix P, Special Procedures for rule 42, will apply.

4 ELIGIBILITY

This event is restricted to Laser, Radial and 4.7's. All must be members of the ILCA – North America or their national class association.

5 ENTRY and FEES

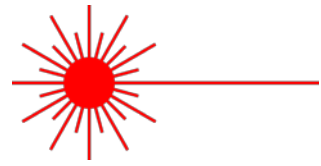
- 5.1 Competitors shall register in advance by completing the online entry form on the TCYC website at <http://www.tcy.org>.
- 5.2 Entry fees received on or before April 24, 2015 will be \$80. Entries received on or after April 24, 2015 will be \$100.
- 5.3 Entry fees include 2 days of racing, 2 sandwich buffets, snacks, fruit, water and awards.
- 5.4 A minimum of five entries is required to constitute a class.
- 5.5 A signed waiver of liability must be received no later than 0900 the first day of racing. Waivers can be executed online as part of the entry form or will be accepted at the competitor check-in desk located in the TCYC Junior Clubhouse.

6 ADVERTISING

Advertising will be governed by ISAF Regulation 20.

7.2 There will be no warning after 1430 on Sunday.

7.3 There are eight (8) races scheduled.

8 SAILING INSTRUCTIONS

Sailing instructions will be available at Registration/Check-In.

9 COURSES

The course will be a trapezoid.

10 SCORING

10.1 The scoring system will be the Low Point Scoring in rule Appendix A

10.2 Three (3) races are required to constitute a championship series.

10.3 When fewer than six (6) races have been completed, a boat's series score will be the total of her race scores.

10.4 When six (6) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

11 PRIZES

Prizes will be awarded to first through third place winners in the Laser, Radial and 4.7 Divisions and to the top female in the Laser, Radial and 4.7 fleets.

12 DISCLAIMER OF LIABILITY

12.1 Competitors participate in the regatta at their own risk. See rule 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

12.2 All competitors must turn in a signed waiver before racing. Competitors under 18 years of age must have the waiver signed by a parent or guardian.
