2015 Laser District 20 Championship and Grand Prix Laser, Radial and 4.7 June 13-14, 2015 Island Bay Yacht Club, Springfield, IL

1 Rules

- 1.1 The regatta will be governed by the Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association (US SAILING), the rules of the International Laser Class Association (ILCA) and this Notice Of Race, except as any of these are changed by the Sailing Instructions or any appendices to the Sailing Instructions.
- 1.2 The organizing authority is the Island Bay Yacht Club. The event will be held at Island Bay Yacht Club, 76 Yacht Club Rd., Springfield, IL.

2 Language

The official language for this regatta will be English.

3 Inspection and Measurement

Sails may be measured prior to racing, and may also be spot checked at any time during the regatta. Note that numbers and letters drawn on the sail with permanent ink pens are not legal. Refer to http://www.laserinternational.org/sailnos.htm for detailed instructions.

4 Eligibility and Entry

4.1 Laser, Radial and Laser 4.7 competitors who are members of the ILCA-NA or their national Laser Class Association may enter by completing registration with the organizing authority. A minimum of five entries are required to constitute a class.

5 Risk

It is the competitor's decision to enter the regatta and to start or continue any race. The competitors are ultimately responsible for the risks. The competitor will accept full responsibility for all his/her actions during any activity related to the event. This includes on-shore activities before, during, and after the regatta.

6 Schedule of Events

6.1 Saturday, June 13

Registration 0900 – 1100, Laptops will be available to register and make corrections i.e. Sail Number etc.

Skippers Meeting 1130

First warning signal 1230, up to 4 races to follow

Annual District 20 Meeting – informal and open to all.

Dinner under the Pavilion after racing

6.2 Sunday, June 14

Harbor gun 0930

First warning signal 1000, races to follow

Awards to follow ASAP after last race.

6.3 No warning signal will be made after 1300 on the final day of the regatta

7 Advance Registration

Competitors may register in advance by completing the standard ILCA-NA registration form online at the Regatta Network, Inc. www.regattanetwork.com/event/10498

8 Fees

- 8.1 Current ILCA-NA membership is required for participation in this event. When registering, you will be directed to search your membership number if you do not know it and view whether you are current. If not current, payment may be made to continue registration.
- 8.2 Required Fees Cash, Checks (Payable to: Island Bay Yacht Club) and Credit Cards Online.

The entry fee is for Laser, Radial and 4.7 entries is as follows:

Laser - \$45.00

Laser radial - \$40.00

Laser 4.7 - \$35.00

Laser-St., Rad, 4.7 Age 18 & under - \$0.00

The Island Bay Sailing Foundation will pay the registration fee for all Junior competitors (age 18 and under). When registering online, choose this fee description.

8.3 The entry fee includes donuts each morning and liquid refreshments for the competitors after each race day. Dinner on Saturday night may be purchased for an additional \$20.00 fee at the time of registration. Multiple dinners can be purchased online at the Regatta Network Storefront.

9 Sailing Instructions

The sailing instructions will be available during on-site registration.

10 Courses & Racing Area

- 10.1 Courses will be standard ILCA-NA courses as described in the ILCA-NA Regatta Guidelines.
- 10.2 The racing area will be Lake Springfield.

11 Scoring

- 11.1The Low Point Scoring System, Appendix A4, will be used except as modified below.
- 11.2 Six (6) races are scheduled, a minimum of three (3) races must be completed to constitute a regatta.
- 11.3 When six (6) races are completed a sailor may discard their worst score.
