Releasors agree to abide by all rules of the Sponsors and the Host in connection with participation in the sailing school, clinic, regatta, On-Water SAIL Standards Course and understand that the failure to observe and obey such rules may result in instant revocation of Releasor's(s') right to participate in the above mentioned events.
