**LOANER BOAT AGREEMENT**

**Responsibility of the Boat Owner**

- To make their Shark 24 available for the Sail Canada Women's Keelboat Championships
- To provide the boat "race ready" prior to inspection.
- To be aware of the current condition of hulls, sails, and all equipment on the boat
- **To provide deductible on insurance policy and a copy of insurance to BYC and the team using the boat**
- To advise the Dock Captain of any issues of note before and as soon as possible after the event
- To be available for boat-team orientation on Wednesday, September 14th between 4 and 7 pm (or assign that job to their representative)

**Responsibility of the team using the boat**

- To check over their Shark 24 for the Sail Canada Women's National Keelboat Regatta
- To be available for a boat orientation
- To be aware of the current condition of hulls, sails, and all equipment on the boat
- To advise the Owner of any issues of note before and as soon as possible after the event
- To ensure damage deposit as specified in NOR is paid.
- **To be responsible for any and all damages to the boat up to the value of the insurance deductible**
