



2016 GRITS 'n HAGGIS REGATTA & 2016 FLYING SCOT DIXIE LAKES DISTRICT CHAMPIONSHIP: NOTICE OF RACE

The Keowee Sailing Club and Flying Scot Fleet 193 invite you to compete in the 2016 GRITS 'n HAGGIS Regatta, which will also serve as the 2016 FLYING SCOT DIXIE LAKES DISTRICT CHAMPIONSHIP. This event is open to all Flying Scots, although only skippers who are both paid Flying Scot Sailing Association members AND members of a chartered FSSA Dixie Lakes District fleet will be eligible to compete for District Championship awards.

This regatta will be held on Saturday, May 21st and Sunday, May 22nd, 2016. Both events will be governed by the 2013-2016 RACING RULES OF SAILING, except as modified by applicable FSSA class rules and/or the Sailing Instructions (available at registration.) Six races are scheduled. One race will constitute a regatta. Courses will be described in the Sailing Instructions. There will be a shared starting time for all races for both events, but separate scoring will be kept.) Some competitors are eligible to compete in both events concurrently.

The entry fee of \$75 per boat covers two days of racing (weather permitting), prizes for the top 7 finishers in the Grits 'n Haggis Regatta and for the top 3 finishers in the Dixie Lakes District Championship, plus a complete weekend food and drink package for two people (includes 2 dinners, 2 breakfasts, 2 lunches, beer & wine, soft drinks, water, etc.) Meals for additional crew members, or for non-sailing guests and family members, can be purchased at registration. Competitors may enter by completing the registration form below, and submitting it either by mail or in person at the on-site registration table, by 11:30am on the Saturday, May 21st. Competitors may also choose to pre-register online and pay later on-site.

The Keowee Sailing Club is located on SC Rte. 130, 2.2 miles north of the US Rte. 123 intersection in Seneca, SC. Grounds open at 4pm on Friday, May 20, 2016 for RV or tent camping. Showers and restrooms are available; however, NO pets are allowed on KSC property. A limited amount of free lodging, in boats at the KSC docks or in the homes of Fleet 193 members, is available -- first come, first served. Child care is also available.
