NOTICE OF RACE

1. Rules

1.1. The regatta will be governed by the Racing Rules of Sailing 2013-2016, together with prescriptions of the US Sailing, A-Class Catamaran, Nacra 20, F16 and CBYRA Beach Cat rules, also to include any additional sailing instructions issued at the competitors' meeting.

2. Eligibility and Entry

- 2.1. The regatta is open to all boats of the A-Class Catamaran, Nacra 20, F16 classes.
- 2.2. The regatta registration site is http://www.regattanetwork.com/clubs/wrsc.php.

3. Fees

- 3.1. Required fees are as follows:
 - Double handed boats \$35.00
 - Single handed boats \$35.00

4. Starts

4.1. All boats will start together.

5. Scoring

- 5.1. Finishing times for boats will be recorded and adjusted according to the SCHRS using the rating available at http://www.schrs.com/ratings.php on October 14, 2016.
- 5.2. The low point system of Appendix A of the racing rules will apply.
- 5.3. The completion of at least one race shall constitute a series.
 - (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.
 - (b) When from 5 to 11 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

6. Prizes

- 6.1. Prizes will be awarded to the top three finishing boats.
- 6.2. The perpetual Rob Wilson Memorial Trophy will be awarded to the overall winner.
