## NOTICE OF RACE

# Lipton Challenge Cup One April 22<sup>nd</sup> & 23<sup>rd</sup> 2017

### 1. **RULES:**

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing,* the prescriptions of US SAILING, pertinent Class/Fleet Rules, the Waikiki Yacht Club Standing Sailing Instructions, Historical Trophies Advisory Board (HTAB) Notice of Challenge and Authorization to Award #17 dated January 18, 2017, this Notice of Race and the Sailing Instructions.
- 1.2. The Racing rules will be changed as follows:
  - 1.2.1. Rule 55 will be modified to read for spinnaker stopping materials only. It still applies to trash.

1.1.1. Rule 63.2 and 63.4 do not apply.

2. ADVERTISING: World Sailing Regulation 20, Appendix 20.2.4 will remain in effect.

#### 3. ELIGIBILITY AND ENTRY

- 3.1. The regatta is open to yachts that meet the challenge and eligibility requirements as defined by the HTAB Authorization to Award, the Notice of Challenge, and the entry requirements as published in this Notice of Race..
- 3.2. Yachts shall have a HYRA valid PHRF rating and submit a certificate to WYC by the deadline stipulated by HTAB
- 3.3. Entrants shall submit a copy of their yacht's insurance certificate at the skippers meeting. 'See item 20 Insurance.'
- 3.4. Eligible boats must attend skippers' meeting and complete all required documents.
- 3.5. Per the Authorization to Award, skippers shall submit a crew list at the skipper's meeting with the following information: Name, State of Residency and the Date joined representative club.

4. FEES: The entry fees will be \$250.00 payable to Waikiki Yacht Club before or at the Skipper's meeting.

### 5. SCHEDULE

- 5.1. Skipper's meeting: 1800 Friday April 21, 2017 at Waikiki Yacht Club (Board Room).
- 5.2. First Warning on first day: 1055 Saturday, April 22<sup>nd</sup> 2017
- **5.3.** First Warning on second day: 1055 Sunday April 23<sup>rd</sup>, 2017
- 5.4. Number of Races: Five races are scheduled.
- 6. SAILING INSTRUCTIONS: The Sailing Instructions will be available at the Skippers Meeting
- 7. VENUE: The Course Area will off the south shore of Oahu
- 8. COURCES: Courses will be displayed by the Race Committee at or prior to the warning of the race as described in the Sailing Instructions
- 9. SCORING: The scoring system is as follows:
  - 9.1. PHRF Handicap rating systems as endorsed by HYRA using Time-on-time

- 9.2. A Minimum of three races is required to constitute a series
- 9.3. Reference is made to Appendix A Scoring, A2 Series Score A.2. Will be modified to reead 'Each boat's series score shall, subject to rule 90.3(b), be the total of her race scores..
- **10. PRIZES:** Prizes will be presented at the awards ceremony after the event. The Sir Thomas Lipton Challenge Cup One Trophy will be awarded to the winner of the series based on the conditions of the Authorization to Award #17.
- 11. DISCLAIMER OF LIABILITY: Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
- **12. INSURANCE:** Each yacht shall be insured with valid third-party liability insurance with a minimum coverage of \$300,000 per event or the equivalent.
